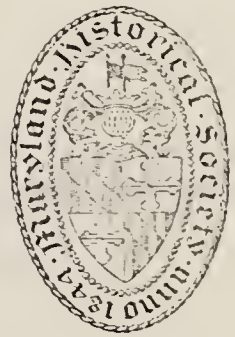

a. A family story related by Cousin Nannie Bowerman declared that Abraham Jackson and Ann Alment were married in Ireland at the home of her aunt, who was the Duchess of Athlone. A check through various peerage lists of the period did not turn up the name of any person who might reasonably be the aunt mentioned, and there was no "Duchess" of Athlone. A safe assumption would be that Abraham and Ann Jackson had a close connection with the Irish nobility, the details of which need further research for clarification.

b. There is a genealogy and biography of Edward A. Jackson in the Tercentenary History of Maryland, vol. II, page 598, which infers that Abraham and Ann Jackson came to Baltimore from Cork, Ireland, and states that at least one of their children (William) was born there. Judging from the material on hand, it appears that they emigrated in 1769.

c. The name "Abraham Jackson" appears on a membership list of Lodge #15, the Fell's Point Freemasonry Lodge, dated June 23, 1770.

d. Abraham Jackson was deeded a lot on Philpot Street, Baltimore (Fell's Point), by John Cattel; received and recorded 1776, Liber AL L, folio #171, Baltimore Co. Land Records.

e. Abraham Jackson took the "Oath of Allegiance" to Maryland, disavowing the sovereignty of Great Britain and her King. His name is third on a list submitted by Isaac van Bibber for Baltimore County, 1778.

f. Abraham Jackson received part of lot #111 from Philip Rogers, and a lot on Philpot Street, both located at Fell's Point, recorded 1779, Liber AL D, folio #141 and Liber AL D, folio #498, Baltimore Co. Land Records.

g. Abraham Jackson received lot #11 on Bond Street from William Fell, recorded 1781, Liber AL F, folio #231, Baltimore Co. Land Records.

h. Abraham Jackson transferred Lot #11 to Simon Zane, recorded 1781, Liber AL G, folio #239, Baltimore Co. Land Records.

i. Abraham Jackson transferred part of lot #11 to William Jones, recorded 1782, Liber AL H, folio #360, Baltimore Co. Land Records.



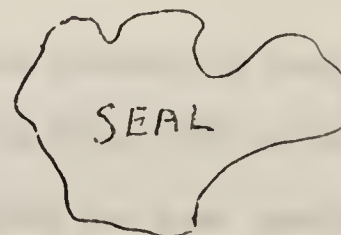

k. The Last Will and Testament of Abraham Jackson, Liber #4, folio #275, Baltimore County Wills, Register of Wills Office, Baltimore, Md. (Microfilm) :

In the name of God Amen. I, Abraham Jackson of Fell's Point Baltimore County and State of Maryland being sick and weak in body but of sound and disposing mind and memory considering the certainty of Death and the uncertainty of the time thereof, and being desirous to settle my Worldly Affairs, and thereby to better prepare to leave this World when it shall Please God to call me hence and therefore make and Publish this my last Will and Testament in manner and form following that is to say. First and principally I commit my soul unto the hands of Almighty God and my body to the Earth to be decently buried at the discretion of my executors hereinafter named and after my debts and funeral charges are paid and my Wifes thirds taken out I devise and bequeath as follows ----- I give and bequeath unto my son William Jackson all that part of Lott in Philpot Street with the working shop thereon together with all my Working Tools and all the Lignum Vita to me belonging. To him the said William Jackson and his heirs and assigns----- Item I give and bequeath unto my daughter Sarah Wife of James Biays, (for whom I have heretofore provided) the sum of one shilling sterling money and no more----- Item, I give and bequeath unto my five following children vizt. Maria, Elizabeth, Anna, Rosannah and Frances all the rest and residue of my estate be it of what nature or kind soever to them and their heirs equally to be divided, and if it should so happen that either of my said five daughters should die without issue I will and desire that such part of such deceased's Portion be equally divided between my other surviving children, Excluding my son William and my daughter Sarah Biays in such division----- And Lastly I do hereby appoint my Dear wife and my son William to be executors of this my last Will and Testament. In Witness whereof I have hereunto set my hand and affixed my seal this sixth day of March, Seventeen hundred and Eighty-seven.

1. Abraham Jackson died October 26, 1787. "Last Thursday morning departed this life Mr. Abraham Jackson, an ingenious useful mechanic of this Town, and on Sunday evening his Remains were decently interred in St. Paul's Church-Yard, attended by a great concourse of respectable inhabitants of Baltimore-Town and its Vicinity-- his Masonic Brethren paying the last affecting Tribute to his Memory by a grand Procession formed at the Lodge at Fell's Point ..... His death is sincerely lamented by his numerous Friends and Acquaintances, particularly his near Relations..... He was a most deserving citizen and worthy member of Society, an affectionate Husband, an indulgent Father, a kind Master, a social Companion, and, above all An Honest Man.

"A Wit's a Feather, and a Chief's a Rod,

An honest Man's the noblest Work of God." The Maryland Journal and Baltimore Advertiser, Tuesday 30 October 1787.

m. The Dielman File at the Maryland Historical Society notes that Abraham Jackson was born in 1744 but quotes no authority for this date. He might have been born in 1743. Both he and his wife were reinterred in Greenmount Cemetery, Area "Q", Lot #46. Her name has been spelled



variously Allmant, Alment, Almont, etc. Their tomb is covered by a flat slab whose inscription can be made out in part with only the utmost difficulty. It reads :

Sacred

to the memory of

Abraham Jackson

who departed this transitory life

the 26th of October 1787

in the 44th year of his age,

but whose name will be had in remembrance

whilst active piety shall distinguish

the Christian

Integrity and truth

the Man

and Universal Kindness

The inventory above was made 4 February 1788 by Messrs. Brittingham, Dickenson and Robert Henderson by virtue of a warrent from the court dated 19 December 1787 and signed by William Buchanan, which authorized a survey. The inventory is filed at the Hall of Records, Annapolis, Md.





a. The Tercentenary History of Maryland, Vol. 2, page 598, has a brief biographical sketch of William Jackson which states that he was born in Cork, Ireland and came to America early in life; that he was known as William Jackson, Joe William Jackson and "Honest Billie" Jackson. It also mentions that he was a major with the 5th Maryland Cavalry which saw action at North Point during the War of 1812.

At the time of his death in 1847, it was reported that he was in his 80th year, which would place the date of his birth as 1768. Other reports gave his age as 80, which would make the first date 1767. No record of a birthday had come to light. He was the eldest of the seven known children of Abraham Jackson and Ann Alment.

b. Ann and William Jackson transferred part of lots #50, #51, #110 and #111 to Robert Britt. Recorded 1792, Liber WG II, folio #535, Baltimore Co. Land Records.

c. William Jackson transferred part of Lot #111 Philpot Street to Levin Jones. Recorded 1794, Liber WG NN, folio #191, Baltimore Co. Land Records.

d. William Jackson was listed as follows in several Baltimore City Directories :

1796- Jackson, William block and pump maker, F. P., 11 Philpot St.

1799- Jackson, William block and pump maker, dw 9 Philpot St., shop 40 Thames St.

1822- Jackson, William, block and pump maker SW corner of Queen st. and the alley leading to Jackson's whf. f. p. dw SE corner of Queen St. and the alley leading to Jackson's wharf f. p.

According to the Tercentenary History of Maryland, Jackson's Wharf is where the family homestead was located and where he became the father of 14 children. It is located at the foot of Bond Street, and now comprises one of the piers of the B & O Railroad.

e. William Jackson transferred part of Lot #23 Queen st. to John Hall. Recorded 1794, Liber WG OO, folio #414, Baltimore Co. Land Records.

f. William Jackson, mechanic, was proposed for director of the Mechanic's Bank of Baltimore, Federal Gazette, Friday 27 June 1806.

g. James Biays granted to William Jackson, etc. part of Ensor's Inspection, 15 $\frac{1}{2}$  acres, deed, recorded 1802, Liber WG 72, folio #319, Baltimore Co. Land Records.





h. "In 1811 James Biays conveyed his ship United States to William Jackson upon its arrival in Philadelphia in order to avoid attachment, but notwithstanding, several attachments were made. When confronted about ownership, Mr. Jackson would not swear to the property." Abstract from a lawsuit involving James Biays.

i. James Biays granted to William Jackson lot #61 on the south-east corner of Fell and Bond Sts. Recorded 1817, Liber WG #141, folio #301, mortgage; Baltimore Co. Land Records.

k. William Jackson and Mary James were married by Rev. Dr. Bend 14 May 1803 according to Baltimore Co. Marriage Licenses, Hall of Records, Annapolis. St. Paul's Parish Register also notes the marriage (in the transcription at the Maryland Historical Society, her name has erroneously been recopied as Mary Jamel.) Her full name was Mary Elliott James, but she was known familiarly as "Molly". St. Paul's Records note that she was born 11 March 1785. She and her mother, Henrietta James, a widow, were both baptised in the Episcopal Church 10 November 1793.

l. William Jackson made a will 13 February 1841 which left everything to his wife, Molly Elliott Jackson and also appointed her Executor. It was witnessed by John Scott, Francis Tiernan and T. Parkin Scott. (Register of Wills, Liber #21, folio #360, Hall of Records.)





m. William and Molly Jackson transferred their membership to Christ Church later in life. Records of this body note the burial of "Captain William Jackson, age 80" on 6 February 1847.

n. "DEATH OF A RESPECTED CITIZEN- Major Wm. Jackson, one of the oldest and most respectable citizens of that part of Baltimore known as Fell's Point, died yesterday afternoon at his residence. He had passed for more than a half score of years, the time allotted to mankind on earth, and had through life borne a most reputable character. He was looked upon by the citizens of East Baltimore as one of those who were regarded as the connecting links between the past and the present; and was held in reverence for his uniform adherence to the place where his fortunes were cast. When others, in the hours of pestilence and death deserted "Old Deptford Hundred", he hung on, and lived and died attached to his first love, honored and respected." Sun, Thursday, 4 February 1847.

"Died yesterday, 3d inst., about 1 o'clock P. M. Major William Jackson in the 80th year of his age. His male acquaintances and friends are respectfully invited to attend his funeral from his late residence, Thames street, on Friday afternoon, at three o'clock, without further notice." American, Thursday, 4 February 1847.

p. "Died- On the 28th instant, in the 74th year of her age, Molly Elliott, relict of the late Major Wm. Jackson.

"Her friends and acquaintances and those of the family are requested to attend her funeral on tomorrow (Sunday) afternoon, at four o'clock, from 121 Park street." Sun, Saturday, 29 March 1862.

q. William and Molly Jackson are buried in Greenmount Cemetery, Area "Q", Lot #46. Their tombstones read as follows :

1. "WM. JACKSON Aged 80 years" This inscription adorns the south side of a tall obelisk.

2. "Mollie E. Jackson

died March 28, 1862

aged 74 years."

r. "Officers of Deptford Fire Co. elected at Pamphillen's Hotel 4 February 1811 :

Directors- Joseph Biays..... Lane Men- Wm. Jackson....." (Federal Gazette, Friday, 8 February 1811.





a. No record of the birth of Sarah Jackson has come to light, but evidence on hand indicates that she was born at Fell's Point, Baltimore, about 1769. Her daughter, Hannah Jane (Biays) Allender, did not check either column in the spaces provided for reporting foreign-born parents in the 1870 Census of the United States. According to Sarah Jackson's tombstone inscription, she was 76 years old when she died in July 1845.

b. "Married at Fell's Point, on Thursday the 10th Inst. Mr. James Byas to Miss Sally Jackson; a very amiable young lady." Maryland Journal, Friday, 18 June 1784. Maryland Marriages, 1777-1804 shows that they were married by the Rev. William West of St. Paul's Parish.

c. Sarah and James Biays lived at Fell's Point until about the turn of the century; then they moved to their newly-built mansion in Waverly on Vinyard Lane, near the York Road. The house was surrounded by many acres of land; the estate was called Mt. Jefferson, a name probably suggested by James Biays' political interests- he was an ardent Jeffersonian Democrat, and as a member of that party, held a seat on the Baltimore City Council. A photograph of Mt. Jefferson exists- as well as a number of paintings by Miss Virginia Jerome Aiken who grew up there in later years- after the Biayses had sold the property. In her anthology, The York Road, Lizette Woodworth Reese has commemorated Mt. Jefferson in her poem "The Abandoned House". Later a sequel to this poem appeared. After standing for about 100 years Mt. Jefferson was deemed unsafe for human habitation and razed.

d. James Biays was a person of many interests and activities, too numerous to list here. Briefly, he was a politician, soldier, merchant and shipowner, public citizen, entrepreneur of such projects as the Biays shipwharves and lumber yard at Fell's Point (with his brother Joseph Biays), the Fell's Point Water Works, also with his brother, etc. He was a committeeman of the 2nd Presbyterian Church of Baltimore. Perhaps his greatest claim to fame is as Lieutenant-Colonel, commanding the 5th Maryland Cavalry at the Battle of North Point in the War of 1812. He was made full colonel 15 June 1817, a commission which he resigned in 1819.

The Biays family, according to his nephew and namesake, James Biays, Jr., emigrated





from Scotland to Northern Ireland, where Joseph Biays was born in 1692. In 1722 he brought his wife and infant son, Matthew Biays (born 1722) to Philadelphia. They were a Presbyterian family. Matthew Biays married in 1752, Elizabeth Dimmit, daughter of William Dimmit, an astronomy professor from London. Of this union five children grew to adulthood- Joseph, Jane, James, Elizabeth and Mary. James was born in Philadelphia in 1760 and baptised at the First Presbyterian Church there 5 February 1762. He and his four brothers and sisters came to Baltimore during the Revolutionary War, in which the two boys served.

e. Sarah Biays, etc. granted the tract Ensor's Inspection to John Litzinger in a deed dated 5 October 1840. This property was purchased by her son, Philip Biays, 11 April 1822, just before the death of his father. It consisted of 7 acres and 2 lots- #247 and #248, for him and John Stump jointly- purchased in trust for and use of Sarah Biays, to go to Nancy Biays, Frances J. Biays and Hannah J. Biays, her heirs, on her death, Baltimore Co. Land Records, Liber WG #145, folio #492. The sale of this property to John Litzinger is recorded in Liber WG #278, folio #42; this was signed by John W. Stump, S. Biays, J. Hoke, Ann E. Hoke, Henry Hammond, Fanny Hammond, Henry N. Bowerman, Elizabeth Bowerman, Walter T. Allender and Hannah J. Allender.

f. In 1844 Sarah Biays and her son, Philip G. Biays, sold for \$1200, the ground which it now occupies, to St. John's Church. By lease and deed, Sarah Biays and children disposed of certain other property in Waverly in 1844, lease to David Mumma 9 November 1844, Liber AWB, folio #174- this piece was then purchased outright by William D. Brown, Liber ANB, #355, folio #70. Another lot in the area was leased by Abraham H. Beckner, Liber ANB #355, folio #469. The heirs of James Biays- all of them family members- witnessed these transactions, with the exception of Philip, then a resident of Montgomery County, Md. Mt. Jefferson passed on to the Brady family, and became known as the "Brady Mansion"; it was thus known when the Aikens rented it from them.

g. "Died- In Baltimore co., 1st inst., at the residence of W. T. Allender, Mrs. Sarah, relict of Col. James Brays." Sun, Wednesday, 9 July 1845 (sic).

h. "Died, yesterday morning, after a short indisposition, at his residence on the York Road,





Col. James Biays." American, Wednesday, 31 July 1822. (sic)

i. Sarah and James Biays are buried in Greenmount Cemetery, Area "D", Lot #18. A tall obelisk marks their final resting place, inscribed as follows :

"Affection's last offering to the memory of Coln. James Biays, died July 19th, 1822, aged 62 years. Also Sarah Jackson, his wife, who died July 1st 1845, aged 76 years. This tomb contains the remains of Mary Ann Biays, who died Augt. 22d, 1820, aged 17 years, also the remains of seven others who died in their infancy, all children of James and Sarah Biays."

j. The date usually accepted as the date of Col. James Biays' death is July 19, 1822.

k. There is a painting of Sarah Jackson in existence, done by one of the Peales- which artist yet uncertain. It was painted when she was a grown woman, depicting her in a bonnet with a pale green trim, and a multicolored shawl of pale background. The painting is owned by Fanny Carter (Mrs. Richard O. Zerbe) of Nitro, West Virginia. She also has a cavalry sword which belonged to Colonel Biays.

l. Mrs. James Biays was dropped from the membership list of the 2nd Presbyterian Church, Baltimore in March 1847. (Records of same.)

m. Baltimore City Directory, 1796 :

Biays, James, ship joiner, Fell's Point, 21 Thames st.

-----, do., shop, do. 23 do.

Biays, James, ship joiner, shop do. So. side Queen st.



a. Mary Ann Jackson was born 17 November 1771, presumably at Fell's Point. She was the third child and second daughter of Abraham Jackson and Ann Alment of whom we have record. She has been listed as "Mary Jackson" and "Maria Jackson".

b. Mary Ann Jackson was mentioned in her father's will; and she signed the inventory of his estate as a kinswoman---- see pages 8 and 12, this paper.

c. "Mary Jackson- daughter of the late Abraham Jackson, married May 24 1791 at Fell's Point to Capt. Levin Jones by Rev. Dr. Allison. Maryland Journal, 27 May 1791, page 3, column 1." (Dielman File, Maryland Historical Society, Baltimore, Md.) Rev. Patrick Allison was minister of the 1st Presbyterian Church in Baltimore.

d. Captain Levin Jones was a native of the Eastern Shore of Maryland, his family being one of the oldest in Dorchester County. Because of a disastrous fire which destroyed the Court House at Cambridge, early records of Captain Jones are difficult to come by. It appears, however, that he came to Baltimore in his youth- during the hey-day of the Baltimore Clipper- and sailed as master for various shipowners, including James Biays. He became a ship-owner himself, sailing his own vessel (s?) and employing other masters.

"Also, schooner Wolf, Jones, 13 days from Charleston-- rice-- the master. Four days since, off Hatteras, spoke the British brig Avon, from England, last from Bermuda, with Mr. Erskine, the British minister on board-- bound to Annapolis. Passed a number of square rigged vessels in the bay did not speak them." Federal Gazette, Tuesday, 30 October 1806.

"For Charleston, the Schooner Wolf (a Regular Trader) Levin Jones, Master, will sail with all convenient speed. For freight or passage (having elegant accomodations) apply to the Master on board, at Jackson's Wharf, Fell's Point." Advertisement, Wednesday, 13 January 1808.

"ar. schr. Wolf, Reeves, 20 ds fr. Antigua, ballast.-- Levin Jones." Federal Gazette, Friday, 13 March 1812.

e. During the time the Joneses lived in Baltimore they resided at Fell's Point, first on Philpot Street (see page 13 this MS) and then on Aliceanna Street (Baltimore City Direct-







ories, 1812.)

Later in life Mary Ann and Levin Jones removed to Dorchester County and took up residence on the magnificent Jones estate, "Castle Haven" a few miles east of Cambridge, Md. The house there is still standing and in excellent repair- one of the show-places of Dorchester Co. The estate comprises an entire peninsula jutting into the Choptank River near its confluence with the Chesapeake Bay. Most likely Captain Jones engaged in agriculture during this period of his life.

f. Captain Levin Jones is buried in the family section at Old Trinity Episcopal Church at Church Creek, Dorchester Co., Maryland. The tombstone reads : "Sacred/ To The Memory Of/ Capt. Levin Jones/ Was Born/ June 10<sup>th</sup> 1764./ And Departed This Life/ Sept. 17<sup>th</sup> 1838/ In The 75th Year Of His Age/ (another line underground, unreadable)."

The stone beside his says "Also- Col. Thomas Jones of the Revolutionary Army/ died 24 March 1808;/ and his consort Elizabeth Jones/ died 9 April 1817." (possibly his parents ?)



g. After the Captain's death, Mary Ann Jones returned to Baltimore, accompanied by numerous slaves, and spent her remaining days in that city.

"DIED- On Wednesday evening, 11th inst., at the residence of Charles A. Williamson, Mrs. Mary Ann Jones, (formerly of Dorchester county, Eastern Shore,) in the 71st year of her age." Sun, Monday 16 May 1842.

h. She is buried in Baltimore Cemetery, Area "N", lot #288, Baltimore, Md., her name appearing on a tall obelisk, just above that of her sister, Frances. The inscription reads :

Mary Ann Jones

born 17, Nov. 1771

died 11, May 1842

Frances Jackson

born 29, Sep. 1780

died 12 Jany 1843

United in life, and in death

they were not seperated.

Note : the odd punctuation and mis-spelling of the word "separated".

i. The Will of Mary Ann Jones of Dorchester Co., presently residing in Baltimore City :

To her three sisters- Elizabeth Thompson, Ann Martin and Frances Jackson- \$500.00 each. If one should die before the testatrix, then "the legacy shall lapse and become part of my general estate. And in that event I give and bequeath the sum of Five hundred dollars, to my two grand nieces Imogene and Rosanna Mills to be equally divided between them, that is to say, Two hundred and fifty dollars<sup>to</sup> each."

Except for the above bequests the whole of her estate was willed to her niece Ann S. Williamson, to go to her husband after her death. If they die childless, the \$500.00 of the estate is to go to their heir and the remainder to be divided by the children of her brother William Jackson and one-half to the children of her sister Elizabeth Thompson.

The Will was dated 10 November 1841 and witnessed by Grafton D. Spurrier, Rudolph Spurrier, and Beale Spurrier. (Abstract, Register of Wills Office, Baltimore, Md., Liber #19, folio #63.)





a. Elizabeth Jackson, the fourth child and third daughter of Abraham and Ann (Alment) Jackson of whom we have record was apparently born at Fell's Point about 1773. She gave her age as "76" in the 1850 United States Census, and birthplace as "Maryland". Cemetery records and an obituary list her age as "88" in August 1861. She outlived all of her sisters and brother, William Jackson. See page #57, this MS.

b. She was mentioned in the Wills of her sisters, Mary Ann Jones and Frances Jackson.

c. She was also one of her father's legatees, and signed the inventory of his goods as a kinswoman.

d. Baltimore Marriage Licenses, Hall of Records, Annapolis, Md., notes that she married Nathaniel G. Thompson 28 July 1792, license same date, and that the marriage was performed by Rev. Dr. Allison. Records of the 1st Presbyterian Church, Baltimore give the same date, but misspell the name of the groom as "Joseph Totten".

e. "DIED- On the 28th instant, Mrs. Elizabeth Thompson, aged 88 years.

"The relatives and friends are respectfully invited to attend her funeral on this (Thursday) afternoon at four o'clock, from the residence of her daughter, (Mrs. Captain Benson,) No. 40 Spring Row." Sun, Thursday, 29 August 1861.

f. She is buried in Baltimore Cemetery, in Area "R", Lot #181, but the grave is unmarked.



a. The fifth child of Abraham and Ann (Alment) Jackson was known as both Ann and Nancy Jackson. In his Will, her father spoke of her as "Anna". According to the United States Census of 1850 she was born in Ireland in or about 1776, but very likely this is an error, for there there is ample proof that the Jacksons were in Baltimore during that year. (See Abraham Jackson's business accounts, pages 10-11, this MS. It is scarcely conceivable that her mother made a return visit to Ireland in that year, then had another child in 1778, because of the Revolutionary War. See page #57, this MS.)

b. She was mentioned in the Wills of her two sisters, Mary Ann Jones and Frances Jackson.

c. She was married to Captain George Martin 30 May 1795 by Doctor Allison of the 1st Presbyterian Church, Baltimore, according to the Hall of Records, Annapolis, Md.

"Married on Sunday last, capt. George Martin to the accomplished Miss Ann Jackson, both of Fell's Point." Telegraph, Wednesday, 3 June 1795. (This would be the 31st.)

d. "On Thursday evening departed this life, Miss Eliza Martin, daughter of Mrs. Mary Martin, of Worcester county, and sister of captain George Martin, of this city.-- Her remains were yesterday interred in the new Presbyterian burying ground, attended by a numerous train of relatives and sympathetic friends, to pay their last sad tribute of respect to her departed worth." Federal Gazette, Saturday, 24 August 1799.

e. "Departed this life, on the 10th instant, at his dwelling on Fell's Point, captain George Martin, in the 39th year of his age, after a tedious illness, which he bore with christian fortitude." Federal Gazette, Monday, 14 April 1806.

His estate was administered 10 December 1806, Ann Martin being his administratrix. Security was posted by William Jackson and James Ramsey. Baltimore County Administrations, Liber #4, folio #159, Court House, Baltimore, Md.

f. "DIED- On the 10th instant, Mrs. Ann Martin, aged 75 years. (Snowhill papers please copy.)" Sun, Tuesday 16 March 1852.

She is buried in Baltimore Cemetery, Area "N", Lot #288. Her tombstone reads : "Ann Martin/  
Relict of/ George Martin/ died March 10 1852/ aged 75 years"





a. Rosanna Jackson was the sixth child and fifth daughter of Abraham and Ann (Alment) Jackson of whom we have record. She was born 21 August 1778, presumably at Fell's Point; and died many years before her sisters and brother.

b. St. Paul's Parish Register notes the marriage of John Smith and Rosanna Jackson 10 December 1797.

c. She is buried in Baltimore Cemetery, Area "N", Lot #288; the tombstone, a flat slab, reads :

Sacred to the Memory of

ROSANNA wife of

Capt. JOHN SMITH

who departed this life on the 18th day of June 1807

aged 28 years 9 months and 28 days

A loving wife and most tender mother

Grieve not my soul, tears cease to flow

The solemn hour is past

She is relieved from human woe

And meets her Savior's breast.

Also SALLY JACKSON SMITH

Daughter of John and Rosanna Smith

Who departed this life April 24th 1802

- a. Frances Jackson, seventh child and sixth daughter of Abraham and Ann (Alment) Jackson of whom we have record was born 29 September 1780, presumably at Fell's Point. She remained single throughout her life.
- b. She was mentioned as a legatee in her father's Will; also Mary Ann Jones', her sister.
- c. "DIED- On the 12th inst., at the residence of Charles A. Williamson, Miss Francis (sic) Jackson, after a long and protracted illness of three years, which she bore with unexampled patience and resignation." Sun, Monday 16 January 1843.
- d. The Will of Frances Jackson provides :
  1. A bequest to Nancy Martin and Elizabeth Thompson of a lot and dwelling on Philpot St., Fell's Point. On their deaths it is to go to her niece Fanny E. Jackson, and should she die without heirs- then to William Jackson, brother of the testatrix- to him and his heirs. \$50.00 for repairs and taxes are to be paid out of the first rent receipts.
  2. A bequest to her grandniece Imogene Mills of \$100.00;
  3. A bequest to her grandniece Rosanna Mills of \$60.00, both to be paid out of her Marine Bank of Baltimore stock.
  4. A bequest to her niece Ann S. Williamson of the rest and residue of her estate, consisting of Marine Bank of Baltimore stock.
  5. That her nephew, William Jackson, is to be Executor.

The Will is dated 16 March 1842, and signed with an "X"- Frances Jackson, her mark. It was witnessed by Molly D. Lee, M. Ellen Horsey and Sam Winchester.

  6. A codicil dated 6 July 1842 provides that of the \$500.00 left to her by her recently deceased sister, Mary Ann Jones, \$300.00 is to go to Charles A. Williamson, \$100.00 to Ann S. Williamson, and \$100.00 to Ann or Nancy Martin.

Filed at the Register of Wills Office, Baltimore, Md., Liber #21, folio #360.

  7. She is buried in Baltimore Cemetery, Area "N", lot #288, in the same lot with three of her sisters. Her tombstone inscription is reproduced on page #22 of this MS.
  - e. "Miss Jackson buried January 14, 1843, age 43 (sic) Christ Church Parish Register.



Issue of William Jackson and Mary Elliott James :

According to the article in Tercentenary History of Maryland, Vol. II, page 598, William and Molly Jackson had 14 children altogether, and the surviving ones were all raised at Fell's Point. A record of the 14 listed below has been gleaned from several sources :

1A1. James Allmant Jackson :

a. He was the eldest child of William and Mary Jackson; was born 10 November 1804 and was baptised in Baltimore, Md., 1 March 1805 (St. Paul's Parish Register).

b. He died in infancy, and was buried 17 October 1806. (same).

1A2. Ann Jackson (I) :

a. Ann Jackson was the second child of William and Molly Jackson, and the first to bear the name "Ann" of two. She was born 23 August 1806, and was baptised at St. Paul's Church, Baltimore, 19 February 1807. (same)

b. She died in infancy, and was buried 2 November 1808. (same).

1A3. William Robinson Jackson :

a. He was the third child of William and Molly Jackson and the oldest to reach maturity. He was born in 1808 (Tombstone Inscription in GMC).

b. The Baltimore City Directory, 1865-66, lists the following :

"Jackson & Smith (Wm. R. Jackson, S. R. Smith) merchandising and produce brokers, 81 Exchange place."

"Jackson, Wm. R. (Jackson & Smith) 121 Park."

c. The Hall of Records, Annapolis, Md., notes that a license was issued for the marriage of Wm. R. Jackson and Amelia A. Hutcheson, 6 Nov., 1841.





"Married- On the 7th inst., by the Rev. Dr. Roberts, William R. Jackson to Amelia A. daughter of the late Jos. Hutcheson of Worcester county, Md." American, Tuesday, 9 November 1841. Dr. Roberts was the minister at the 1st Methodist Church, Baltimore, Md.

d. "DIED- On the 28th instant, Amelia Ann, wife of W. R. Jackson, in the 26th year of her age (Princess Ann and Snow Hill papers please copy).

"Her friends and acquaintances are invited to attend her funeral from her late residence, in Charles street, third door above Saratoga, on to-morrow (Tuesday) morning, 30th instant, at ten o'clock." Sun, Monday, 29 July 1850.

e. See the 1850 United States Census Report, page #15, this MS.

f. William Robinson Jackson married Annie M. Patrick 3 February 1852. (Christ Church Parish Register).

g. "Jackson- Departed this life, on Wednesday morning, 28th of September, after a lingering illness, Mrs. Annie M. Jackson, consort of the late William R. Jackson.

"Her relatives and friends are respectfully invited to attend her funeral this (Friday) afternoon at four o'clock, from her late residence, No. 7 North Exeter street." Sun, Friday, 30 September 1870. Christ Church Records note the burial of Mrs. Ann M. (Patrick) Jackson, age 39 years, in Baltimore Cemetery.

h. "DEATH OF A WELL KNOWN CITIZEN- Mr. Wm. R. Jackson, well known to the mercantile community, died quite suddenly at his residence in this city, of pneumonia. The deceased was in his 58th year. In early life he made a number of voyages to South America as super-cargo aboard Baltimore clippers. Subsequently he was for many years chief clerk in the well known house of R. C. Wright & Co., and for the past few months occupied (sic) the same position in the house of Mordecai & Co. 1A4. John James Jackson :

a. The fourth child of William and Molly (James) Jackson has been found as John "Jay", John "James" and- as is usually the case-"John J." Jackson. "James" was given preference in this paper because that record was among the entries in Christ Church Parish Register. He was born, according to his tombstone inscription, in August, 1809.

b. "Married on the 30th ult., by Rev. J. Bernard, Captain John J. Jackson to Miss Catherine E. Bier, of this city." American, 2 June 1849. The license was issued 29 May 1849 (Hall of Records, Annapolis, Md.). Her parents were George Bier, Baltimore merchant, and Jane Augusta Wilson Cunningham, the latter a daughter of Capt. John Cunningham from Scotland and Margaret Mathers from Ireland (Dielman File, Maryland Historical Society).

c. "Jackson, Capt. John J. 261 e Baltimore", Baltimore City Directory, 1858/59.

d. "DIED- Off Madagascar, on the 15th of December last, on board the ship Kate Hooper, of Baltimore, Capt. John J. Jackson, of this city." Sun, Tuesday, 22 February 1858.



d. "DEATH OF A BALTIMORE SEA CAPTAIN- Capt. John Jackson of the ship Kate Hooper, died in Macao Straits, on the 15th of December, after a protracted illness. It will be remembered that this vessel was employed to take a cargo of 650 coolies from China to Havana, a portion of whom revolted, and whom it became necessary to kill before order was restored. In this affair Capt. J. exposed himself a good deal, which brought on fever, from which he died. The ship reached her point of destination after a voyage of 116 days, in charge of the first officer, Francis Bowen. There is also intelligence of the death of three of her apprentices. Capt. J. was well and favorably known as one of the most skillful navigators out of this port, and his decisive action at the time of the revolt on board his ship showed him equal to any emergency." Sun, Tuesday, 22 February 1858.

The Tercentenary History of Maryland, Vol. II, page 598, says that his name was John Jay Jackson, and that he was killed by Malay pirates in 1856.

e. For a number of years preceding her death, Catherine Bier Jackson's name appeared in the Baltimore Blue Book.

f. "DIED- On November 1, 1904, Catherine B., wife of the late John J. Jackson.

"Funeral services at her late residence, No. 923 Cathedral street this Wednesday, November 2, at 3 o'clock. Interment private." Sun, Wednesday, 2 November 1904.

g. John J. Jackson and his wife are buried in Greenmount Cemetery, Area "Q", Lot #46.

a. The fifth child of William and Molly Jackson of whom we have record was born about 1811, and named for his paternal grandfather.

b. "DIED- On the 2d inst., Abraham, son of Major Wm. Jackson, in the 35th year of his age." Sun, Wednesday, 6 August 1845.

c. He is buried in Greenmount Cemetery, Area "Q", Lot #46. His tombstone reads :

1A6. Henrietta Jackson

a. The sixth child of William and Molly Jackson of whom we have record was born 21 September 1812, and baptised 25 March 1815 (St. Paul's Parish Register).

b. She was married by the Rev. Johns to Robert M. R. Smith on 1 December 1831 (Christ Church Parish Register and Hall of Records, Annapolis, Md.)

c. "DIED- On the 18th inst., at her father's residence, Henrietta M., wife of Robert M. R. Smith, and daughter of Major William Jackson." Sun, Saturday, 20 September 1845. She is buried in Greenmount Cemetery, Area "Q", Lot #46. Her tombstone reads :

a. Mary Jackson, the seventh child of William and Molly (James) Jackson of whom we have record, was born 31 January 1814. She and her two sisters, Henrietta and Ann were baptised 25 March 1815 (St. Paul's Parish Register).

1A8. Ann Jackson (II) :

a. The eighth child of William and Molly (James) Jackson of whom we have record was born 11 March 1815, and was the second of their children named for her paternal grandmother. She and two of her sisters were baptised 25 March 1815 (St. Paul's Parish Register).

1A9. Benjamin Chew Jackson :

a. The ninth child of William and Molly (James) Jackson was born 19 May 1816. He was baptised 6 June 1816 (St. Paul's Parish Register).

b. "DIED- On Wednesday afternoon, 28th inst., at half-past two o'clock, Benjamin Chew, fourth son of the late Major William Jackson in the 32nd year of his age. (New Orleans papers please copy)." Sun, Thursday, 29 July 1847.

c. He is buried in Greenmount Cemetery, Area "Q", Lot #46. His tombstone reads :

1A10. Amelia Jackson :

a. The tenth child of William and Molly (James) Jackson was born 12 November 1817 and baptised 14 January 1818. (St. Paul's Parish Register).

b. The Hall of Records, Annapolis, Md., notes that a license was issued 20 December 1838 for the marriage of Amelia Jackson and George R. Smith. Rev. Mr. Peterkin performed the ceremony.



c. "DIED- On the 30th of Sept., Amelia, relict of the late Geo. R. Smith, of Snow Hill, Md., aged 33 years.

"Her friends and acquaintances and those of her mother, Mrs. M. E. Jackson, are invited to attend the funeral this (Wednesday) afternoon, at 4 o'clock, from the latter's residence, No. 63 N. Charles street." American, 1 October 1851.

1A11. Edward Alment Jackson :

a. The eleventh child of William and Molly (James) Jackson was born 27 January 1819. He was baptised 1 January 1820 (St. Paul's Parish Register).

b. "DIED- At Yazoo City, Mississippi, on the 6th inst., Edward A. Jackson, in the 23d year of his age, son of Major William Jackson, of Baltimore." Sun, Wednesday, 24 August 1842.

1A12. Charles Henry Jackson :

a. The twelfth child of William and Molly (James) Jackson of whom we have record, was born 2 February 1822. He was baptised 25 February 1822 (St. Paul's Parish Register).

b. He was buried 1 September 1825, aged 3 years, 7 months (same).

1A13. James Biays Jackson :

a. The thirteenth child of William and Molly (James) Jackson, of whom we have record, was born 8 July 1824 and baptised 18 January 1825 (St. Paul's Parish Register). His middle name is spelled "Byus" in this entry, but more than likely he was named for his uncle, Col. James Biays, husband of Sarah Jackson.

1A14. Frances Elizabeth Jackson :

a. The fourteenth and youngest child of William and Molly (James) Jackson of whom we have record was born 11 December 1827 and baptised 27 May 1828 (St. Paul's Parish Register).





b. The Parish Register of Christ Church, Baltimore, Md., shows that "John Sewell married Fanny E. Jackson 26 October 1852." John Tyler Seawell was born in Virginia in December 1808. He was a brilliant lawyer and orator. His first wife was Elizabeth Hairston, by whom he had Henrietta and Louisa Seawell. His father, John Boswell Seawell, married 23 December 1800 Maria Henry Tyler at Greenway in Charles City County at the residence of her father, Governor John Tyler. She was but sixteen years old (William & Mary Quarterly, 1st Series, Vol. VIII, pages 56 and 62). President John Tyler was Maria's brother.

c. Frances Elizabeth Jackson was mentioned in the Will of her Aunt Frances Jackson who died in 1843. See page 27, this MS.

d. "DIED- On May 3, at her residence no. 1605 O St. Fanny E., wife of the late John Tyler Seawell of Gloucester Co., Va." Sun, Thursday, 4 May 1899.

"Seawell. At her residence, in this city, on Wednesday, May 3, 1899, Frances Elizabeth, widow of the late John Tyler Seawell of Virginia and daughter of the late Major William Jackson of Baltimore. Interment at Baltimore." The Evening Star, Saturday, 6 May 1899.

"Mrs John Tyler Seawell, mother of Miss Mollie Elliott Seawell, the well known Southern Authoress, died suddenly here today after a brief illness. Mrs. Seawell was born in Baltimore and was a member of the Jackson family, prominently identified with the commerce between Baltimore and the East Indies during the early part of the century. The funeral will take place in Greenmount Cemetery, Baltimore, on Thursday." Sun, Thursday, 4 May 1899.

e. She is buried in Greenmount Cemetery, Baltimore, Md., Areq "Q", Lot #46. Her tombstone reads :

The most accurate count of the children of Sarah Jackson and James Biays places their number at 14. Some of these were born when the family lived at Fell's Point; others when they lived in Waverly, Baltimore County, after the turn of the century. It would probably be a safe assumption that Mary Ann Biays and all of those who followed were born in the latter place. Seven are known to have died in infancy (see page 19, this MS.)

1B1. Abraham Biays :

- a. The eldest child of James and Sarah (Jackson) Biays was born 4 June 1785 and baptised 20 July 1785 (1st Presbyterian Parish Records); named for his maternal grandfather.
- b. He is presumed to be one of the seven who died in infancy.

1B2. Matthew Biays :

- a. Matthew Biays, second child of James and Sarah (Jackson) Biays, was born 4 April 1787. He was baptised 1 June 1787 (1st Presbyterian Parish Records).
- b. He is presumed to be one of the seven who died in infancy.

1B3. Joseph Biays :

- a. Joseph Biays, third child of James and Sarah (Jackson) Biays, was born 23 March 1788. He was baptised 12 June 1788. (1st Presbyterian Parish Records).
- b. He is presumed to have died in infancy.

1B4. Anne Biays (I) :

- a. Anne Biays, fourth child of James and Sarah (Jackson) Biays, was born 18 May 1790. She was the first of at least two children to bear the name "Anne". (See 1B6 and 1B14). She was baptised 5 June 1790 (1st Presbyterian Parish Records).



b. She is presumed to have died in infancy.

1E5. Sarah Biays :

a. Sarah Biays, fifth child and eldest to reach maturity of the issue of James and Sarah (Jackson) Biays, was born 26 October 1792. She was baptised 16 December 1792 (1st Presbyterian Church Parish Records). The Genealogy of the Stump family at MHS erroneously gives 1794 as the year of her birth.

b. "Married last evening by the Rev. Mr. Glendy, Mr. John W. Stump, to Miss Sarah Biays." American, Friday, 14 January 1814. John Wilson Stump was a son of John Stump and Cassandra Wilson, the elder Stump being one of the wealthiest Marylanders of his day. The son was born in Cecil County 23 February 1792 and died at Oakington, one of the Stump estates, 21 October 1862. (Stump Genealogy).

c. "DIED- At his residence, Stafford, Harford county, on the 21st instant, John W. Stump, in the 71st year of his age." Sun, Thursday, 23 October 1862.

d. "Stump- At the residence of her son, near Belair, on Friday, May 19, Sarah Biays, in the 83d year of her age, widow of John W. Stump.

"She will be buried near Stafford on to-morrow, (Sunday) 21st instant. Services at the house at ten o'clock A. M." Sun, Saturday, 20 May 1876.

e. John Stump's will is dated 26 September 1859 and is filed at the Court House in Belair, Harford County, Md. Among its provisions is a bequest to his daughter Mary B. Stump of  $\frac{1}{4}$  of his entire estate because of her helpless and dependent condition. Should she prove too incompetant to manage it herself, her brother, Herman Stump, was to be trustee for her.

He bequeathed only 1/18th of his estate to his daughter Pricilla, since she was by far best off of all his children. The remainder he ordered to be divided among Cassandra, wife of Septimus Norris, Sarah, wife of James Murray, John W. Stump, Jr., William Stump, T. B. Coleman Stump, and Herman Stump, Jr.





a. This child was born 16 December 1794 and baptised 29 December 1794. (1st Presbyterian Church Parish Records). Because the name of the fourteenth child has not come to light (see B14 below) and because of the fact that this child, if the wife of Jacob Hoke, as is assumed, would be about five years his senior, it is possible that she was one of the seven who died in infancy, and that there was yet a third "Anne" who married Mr. Hoke.

b. "Married- At Mt. Jefferson, Baltimore county on Tuesday evening, 9th inst. by the Rev. Dr. Glendy, Mr. Jacob Hoke of Harford county to Miss Ann, second daughter of the late Col. James Biays." Federal Gazette, Wednesday, 10 December 1823. Jacob Hoke was a son of Peter and Catherine Hoke of York County, Pennsylvania. From his parents he inherited considerable property including the farm upon which he lived.

c. Jacob and Anne Hoke made their home at "Wilton Farm" in Harford County, Md. This farm comprised the finest acreage of Jacob Hoke's numerous lands.

d. The last Will and Testament of Ann B. Hoke is on file at the Court House, Belair, Md., Liber WSR #9, folio #74. It reads as follows :

I will and bequeath to my Daughter Kate Greenway my marble top Table, the Ivan Dixon time Piece and my son Peters chair, and to my Granddaughter Virginia my son Peters watch chain & Seal, to my daughter Sarah B. Henriques, I will and bequeath all the furniture silver glass and china contained in my House with the exception of the Blue Room furniture which I bequeath to my daughter Fanny Hoke, also 1 silver dinner spoon 1 desert spoon & 1 Teaspoon, 1 silver dinner Fork & 1 Tea Fork. Also the Piano and Stool. Should Mr. Hoke survive me the above articles are to remain in his possession, and at his death disposed of as I have stated.

e. "DIED- Hoke- On Wednesday, October 27, Mrs. Ann B. Hoke, wife of Jacob Hoke, and daughter of the late Colonel Biays." Sun, Friday, 29 October 1875.

f. "Hoke- On Thursday morning, January 6, 1876 at Wilton Farm, Harford county, Maryland, Jacob Hoke, in the 77th year of his age.

"His funeral will take place from his late residence on tomorrow (Saturday) afternoon, 8th instant, at two o'clock." Sun, Friday, 7 January 1876.

g. Jacob and Ann Hoke are buried in Spesutia Cemetery near Perryman, Md. Their tombstone reads :

h. Jacob Hoke's will is also on file at the Court House in Belair, Liber WSR #9, folio #73. He provided a bequest of \$600.00 per annum to his daughter Fanny Hoke in semi-annual payments of \$300.00 as long as she remained unmarried, beginning six months from the date of the death of his wife. Should she marry she was to forfeit the legacy to her sisters.

The sisters, Kate Greenway and Sarah B. Henriques, were also provided for and forgiven the large sums of money that they had borrowed from their father. The Will is dated 1868. The two sons-in-law, John Henry Greenway and Joseph Henriques were appointed Executors. It was witnessed by William B. Morgan, Charles B. Hitchcock and John L. Williams, who appeared and attested to its validity 17 January 1876.

1B7. William Biays :

a. William Biays was born 6 March 1796 and was baptised 26 July 1796. (1st Presbyterian Church Parish Records).

b. He is presumed to have died in infancy.

1B8. Philip Grable Biays :

a. Philip Grable Biays was the only son of James and Sarah (Jackson) Biays to reach maturity. He was born 18 August 1797 and baptised 9 April 1798 (1st Presbyterian Church Parish Records). The writer has not learned for sure whence came the middle name "Grable" but noted that there was a Philip Grable living in Philadelphia in the late 18th Century; he died about 1780, and his name is among the tax records in the Archives of Pennsylvania.

b. He was a private in Captain Sterrett's Company, 1st Baltimore Hussars, and saw action at North Point during the War of 1812 (Citizen Soldiers at North Point and Fort McHenry). He was "at that period a lad of sixteen years..... insisting upon going with his father; his father warned him, "Now, Phil, if you run I will shoot you." This was the salutation he received upon entering his duties as a soldier." (Portrait and Biographical Record of the Sixth Congressional District of Maryland, 1898).





c. Philip Grable Biays and his wife lived on their estate, Mt. Jefferson, in Waverly until 1832, when they "removed to Montgomery County, and purchased a farm of 261 acres west of Rockville, called Springfield, the farm which is now the property of Charles Veirs." (ibid.) Mt. Jefferson was the home built by his father, Col. James Biays about the turn of the century.

d. Philip G. Biays obtained the property "Huntingdon" on the York Road in Waverly from James Carroll, Sen. and others, date recorded 7 July 1823. This was very likely a small bit of the "Huntingdon" property which his father had purchased piecemeal and from which the Episcopal Church and parish of St. John's, Huntingdon gets its name. Baltimore County Land Records, Liber WG #169, folio #672.

e. In a deed bearing date 11 April 1822, he was granted by John McFadon a seven acre tract of land called Ensor's Inspection, and two lots, #247 and #249. He and John Stump received the tracts jointly, and the deed states that they were purchased in trust for and use of Sarah Biays, to go to Nancy Biays, Frances J. Biays and Hannah J. Biays, her heirs, on her death. This transaction is dated just a short time before the death of his father. Baltimore Co. Land Records, Liber WG #165, folio #492.

f. In a deed dated 6 April 1827 is recorded the purchase of two tracts of land for the sum of \$4000.00 by Philip G. Biays from Andrew H. Woods. The first of these- Buck's Purchase- comprised 100 acres, the second- Poor Jamaica Man's Plague- comprised 50 acres, 27 perches. In this deed his name was mis-spelled "Brays". Baltimore Co. Land Records, Liber WG #185, folio #346.

g. The next deed in which he is mentioned is dated 13 September 1830. The heading is "Philip G. Biays to the United States of America" and reads "Philip G. Biays lately applied to the Secretary of the Treasury of the United States to be released from confinement under a certain Judgement and execution against him at the suit of the United States and that the Secretary by virtue of the powers and authority vested in him by an act of Congress passed the sixth day of June one thousand seven hundred and ninety-eight entitled "An act provided for the relief of persons imprisoned for debt due to the United States" did on the





twenty-third of June, eighteen hundred and thirty authorize a discharge from imprisonment of the body of the said Philip G. Biays on the payment of costs and on the condition that the said Philip G. Biays should assign and convey to the use of the United States of America all his estate real personal and mixed." Baltimore Co. Land Records, Liber #207, folio #165.

h. Bearing date 2 April 1832 is an Inquisition under which Sheriff Henry Green seized certain land belonging to Philip G. Biays for passage of the Baltimore and Susquehanna Railroad.

Baltimore Co. Land Records, Liber <sup>WG</sup>#271, folio #1.

i. For the sum of \$5000.00, Philip G. Biays and wife deeded to Henry N. Gilles the two tracts of land- Buck's Purchase and Poor Jamaica Man's Plague mentioned above (f.). This transaction bears date 27 May 1833, Baltimore Co. Land Records, Liber WG #278, folio #42.

j. The tract Ensor's Inspection, located on the York Road, mentioned above, was disposed of 5 October 1840. See "e.", page #18, this MS.

k. see "f.", page 18, this MS for deed to David Mumma.

l. Philip G. Biays was apparently ill for some time prior to his death, and made careful preparation for the welfare of his family when that event transpired. Among the records of the Montgomery Co. Land Office, is a deed bearing date 20 March 1843 by which Philip G. Biays received for the sum of \$3915.00 the tracts "Part of Younger Brother" and "All We Can Get" and put them in trust for his wife at the request of Alexander C. Magruder, his father-in-law and trustee. Boyd's History of Montgomery County states that the tract "Younger Brother" lies west of Watt's Branch, and was surveyed for William Offutt, August 21st 1719, containing six hundred acres, and comprises the farms of William Veirs and Joseph T. Bailey.

m. Just before his death, and bearing date 13 June 1845 is a transaction by which Philip G. Biays conveyed to John H. T. Magruder for \$5.00 in hand "for the use and benefit of my wife Jane Catherine Thomas Biays and her issue, born to the said Philip G. Biays" the following :

n. Philip Grable Biays was married to Jane Catherine Thomas Magruder, the daughter of Alexander Contee Magruder, Judge of the Maryland Court of Appeals and Rebecca Bellican Thomas, and descended from several old Maryland families.

"Married- On Saturday evening last at Annapolis, Mr. Philip G. Biays of this city to Miss Jane C. Magruder, eldest daughter of A. C. Magruder, esq. of the former place."

Federal Gazette, Saturday, 16 May 1825. From this announcement it appears that the wedding took place on the 9th of the month, but the Hall of Records, Annapolis, Md. notes that the license was purchased on 12 May 1825.

o. "Died, on Monday last, at his residence near Rockville, Md., Mr. Philip G. Biays, formerly of Baltimore, in the 48th year of his age." American, Thursday, 24 July 1845.

p. Jane Catherine Thomas (Magruder) Biays died 31 January 1879, after having returned to live in Baltimore for a short time after her husband's decease, but spending her last days in Montgomery County.

1B11. Frances Jackson Biays :

- a. This child, known better as "Fannie" or "Fanny", was born 7 March 1807.
  - b. She was named as one of her mother's heirs in a deed of trust provided by her brother, Philip in 1840. See page #18, "e.", this MS.
  - c. "MARRIED- At. Mt. Jefferson, on Tuesday evening last by the Reverend Dr. Glendy, Mr. Henry Hammond of Baltimore to Fanny, daughter of the late Col. James Biays." Federal Gazette, Thursday, 26 July 1827. Henry Hammond was the only surviving son of John Hammond and his second wife, Elizabeth Anderson, both immigrants from Ireland.
  - d. The Hammonds lived at 8 Hanover Street, near Baltimore until the late 1830s. A deed among the Harford County Land Records, bearing date 17 September 1838, records the purchase of a tract of land from Henry Fulford of Baltimore City by Henry Hammond for the sum of \$4250.00. \$1062.50 was paid down with promissory notes covering the remainder of the payment, with certain real estate in the city of Baltimore put up as collateral. These notes, four in all, were for \$796.87 each- the first payable in six months; the second in twelve months; the third in 18 months; and the fourth in twenty-four months. The contract was arranged by private sale.
- The tract thus acquired by Henry Hammond, where Henry Fulford had resided, was known as "Miles Hill", "a Farm or parcel of land situate and lying in Harford County aforesaid ..... consisting of several tracts or parts of tracts vizt. Miles Hill, Whitaker's Ridge, Addition and Montreal or Monreal containing together and in the whole as it is believed





two hundred and sixty-two acres and one-half of an acre."

Henry Hammond's mother, widowed for the second time in 1826, and known as Elizabeth Casey, made her home with them, until her death in 1849.

e. Another deed among the Harford County Land Records, bearing date 16 November 1841 and sent by mail to W. Spurrier per order filed, avers that "Henry Hammond, declaring himself to be in debt to his mother, Eliza Casey for the sum of \$8730 for money lent and advanced by her to him, in order to secure payment within seven years of the above date, did turn over to her \$5 lawful money and the debt the following :

10. six beds, bedsteads and mattresses
11. two mahogany wardrobes, three dressing tables, three wash stands and appendages, chamber carpets and chairs
12. a variety of table linen, sheets and blankets
13. three pair of andirons, shovels and tongs
14. a passage and stair carpet with rods
15. sundry kitchen utensils and furniture, generally all being in the said house
16. a mulatto woman slave named Frances and her female child in the possession of the party of the first part hereto
17. four horses, six cows, two calves, one yoke of oxen, twenty sheep, twenty hogs, one family carriage and harness





18. one carry all, one farm wagon

19. one ox cart

20. sundry plows and a harrow now being on the aforesaid farm

21. and generally "all other the chattels live stock farming and plantation utensils and implements of husbandry of every description on the Miles Hill farm aforesaid being and belonging to the party of the first part hereto."

To Eliza Casey- her heirs and assigns forever

f. Another deed among the Harford Co. Land Records, dated 18 October 1843, shows that Henry Hammond turned over all his belongings to A. Lingan Jarrett under the 1805 act entitled "An act for the relief of sundry insolvent Debtors." Mr. Jarrett was appointed trustee for the creditors by the judge.

g. Fanny (Biays) Hammond and her children were the sole legatees of the Will of Elizabeth Casey, bearing date 15 May 1847. She died 1 April 1849. Except for certain specific bequests, the estate went directly to Dr. Walter Tolley Allender to be held in trust for the benefit, proper use and behoof of Fanny Hammond and children.

The census report is from a photostat of the original at the National Archives, Washington, D. C. Henry Hammond was already dead on the 25th of September, 1850, a fact which would indicate that the report was filed some time after the figures were obtained. The "B" following the age and sex of the last three persons shows that they were Negroes. The "5000" in the 4th column is the value of Henry Hammond's real estate. The "1" in the final column shows that Fanny B. Hammond attended school in the preceding year.

i. Henry Hammond's life ended in tragedy. For some time before his death, ill feeling existed between the families of the Hammonds and Stumps. Although there was no indication that the two sisters were at odds, John W. Stump, and especially his sons, indicated their displeasure with Henry Hammond by countenancing a rumor that he had taken liberties with Mary Biays Stump on an occasion when she was in his custody. She was mentally defective, and it is doubtful if the charges were true, but true or not, her brother, John Wilson Stump, Jr. had his brother-in-law John Leypold Griffith drive him to the Hammond farm with William Stump, where, according to his own account, he surprised Henry Hammond in the garden and shot him dead.

"ATROCIOUS MURDER- The following are the particulars of a most atrocious murder, which occurred in the vicinity of Perrymanville, Harford County, near the Baltimore and Philadelphia Railroad on Wednesday. It appears that Mr. Henry Hammond, aged about 46 years, having dined, retired into his garden for the purpose of enjoying a cigar. He had not remained there long before the sharp crack of a gun was heard, and on entering the garden a few minutes after it was found that the contents (buck shot) had entered his back and sides, killing him instantly. An inquest was held on the body, and a verdict rendered that he came to his death from a gunshot wound inflicted by some person unknown. Late in the





evening rumors of various kinds were afloat as to the supposed guilty party, and the cause of the deed, which will, we presume be fully investigated. Mr. Hammond was well known in this city as a modest unassuming gentleman. He has been residing in Harford County about 12 years, previous to which he lived in Baltimore." Sun, Saturday, 3 August 1850.

j. "Bel Air, Harford County, Md. Thursday, August 15, 1850- The recent melancholy tragedy which occurred in this county, whereby a very much esteemed and popular resident, Mr. Henry Hammond was plunged into a premature grave by an assassin, has formed the all-engrossing topic of conversation, and public opinion is not so unanimous in the justification of such a horrid crime as the patrons of lawlessness would desire.

There are many gentlemen of intelligence and correct views of society, who have strong confidence in the innocence of the deceased; a man who up to his death solemnly declared his innocence. But apart from the innocence or guilt of the accused, they deeply deplore that element in the judgement of society which sanctions the usurpation of and disregard for the law, as evidenced in the murder, as well as that ultraism of sentiment which arrogates to any person the right to administer punishment to supposed or alleged offenders.

Alas for Mrs. Hammond-- a lady uniting in her character those traits which adorn and elevate human nature; pity for those eight children, who have been untimely bereft of a fond and doting father. With a keen and awful recollection of the distressing end of her husband, Harford presents no relief to her mind, and she will, as soon as circumstances permit, dispose of the country seat, remove to another section of the country.

A word in relation to the alleged cause of the murder. Mr. Hammond is charged with having taken advantage of a lady in the bloom of youth, whose intellect is impaired by periodic visitations of lunacy, and that at a time when she was under his protection, and in the season of enjoyment consequent upon a large assemblage of relatives and family connexions. In the absence of any direct proof of his guilt, it would become a charitable and prudent mind to wait for a legal investigation of all the facts, ere a condemnation is so profoundly lavished upon his memory. Many who knew him best totally discredit the rumor.





Mr. Coleman Stump, of Baltimore, a young brother of the young man who is accused of the murder, was arrested a few days since, by officer Hopkins, of Belair, and examined before a magistrate, near Perrymansville, upon the charge of being concerned with the murder. The evidence, however, failed to criminate him, and he was honorably discharged." Sun, Thursday, 20 August 1850.

a. Elizabeth Biays- the second daughter of Col. James and Sarah (Jackson) Biays, by this surname, was born in 1810. No record of her birth or baptism has come to light other than the year.

b. "Married on the 31st ultimo, by Mr. Healy, Henry N. Bowerman, to Elizabeth, daughter of the late Col. James Biays of this city." American, Tuesday, 3 February 1829. Henry Neville Bowerman, a son of Henry Bowerman and Grace Neville, emigrated to America from Limerick, Ireland with his brother Richard P. Bowerman. It has also been said that they were accompanied by yet a third brother who returned to Ireland, finding little to his taste in the New World.



c. Although the Bowerman brothers arrived in Baltimore about 1825, there is no listing in the Baltimore City Directory for either until 1837. Several listings are :

"The relatives and friends of the family are respectfully invited to attend her funeral on this (Friday) afternoon, at five o'clock, from her late residence, No. 348 West Fayette street, without further notice." Sun, Friday, 22 June 1860.

e. "DIED- Bowerman- On the 15th instant, Henry N. Bowerman, in the 71st year of his age.

1B13. Hannah Jane Biays :

a. Hannah Jane was the youngest child of Col. James and Sarah (Jackson) Biays to reach maturity. She was born about 1809; no record of the exact date has been found.





b. "Married- On Thursday evening last by the Reverend Mr. Bartow, Dr. Walter T. Allender to Miss Hannah Jane, youngest daughter of the late Col. James Biays." Federal Gazette, Monday, 29 November 1830. Dr. Walter Tolley Allender was a first cousin, once removed to Hannah Jane Biays. He was a son of Dr. Joseph Allender and Mary Biays and was born at 6 A. M. on Tuesday, 9 June 1807 (Allender Family Bible). His mother, Mary Biays, was the eldest daughter of Col. Joseph Biays and Mary McMullen, the former being a brother of Col. James Biays.

c. Dr. Walter T. and Hannah Jane Allender made their home on their fine country estate in Baltimore County on the Bird River which was called "Mt. Ararat". The house burned many years ago, but many of the Bowerman descendants live in the vicinity today on small parcels of the divided estate. (The Allenders had no children of their own.) The house was the subject of a small painting by Col. von Stamp.

A genealogy of the Williamson family at MHS states that Charles Alexander Williamson was a son of David Williamson, Sen. and his second wife, Juliana Johanna de Mulet, the latter born near Bruges, Belgium. They were married 16 December 1795 and had nine children. Charles Alexander was born 2 July 1800.

This genealogy goes on to say that he married Ann Wyer, 1 May 1832; that she was a widow from New Orleans, nee Wedderstrand. (It is possible that she was related to the Wedderstrands on the Smith side, but certainly this is erroneous information.)

Elizabeth Coleman, mentioned above, was an Irish-born servant who lived with the Williamsons and was left a bequest in Charles A. Williamson's Will. She is buried beside her master and mistress in New Cathedral Cemetery, Baltimore, Md. following her death at St. Agnes Hospital 22 November 1892. A piece in the Sun noted that she was 75 years old and had been at St. Agnes for the past 15 years. Her mother, also Elizabeth Coleman, is buried in the Jackson sisters' lot in Baltimore Cemetery, her tombstone noting that she died 18 July 1832, in the 37th year of her age. (Baltimore Cemetery, Area "N", Lot #288.)

e. "Williamson- On Sunday morning, the 24th instant, Mrs. Ann S., wife of Charles A. Williamson.

"The relatives and friends of the family are invited to attend her funeral.

He was one of the first members of the old "Baltimore Club", when its rooms were in Fayette street, between North and Charles streets, and was for a number of years the president of





the organization. After change of name to the "Maryland Club", and removal to the corner of Cathedral and Franklin streets, Mr. Williamson became one of the governors, and continued to hold this office until his death, esteemed and respected by the other governors, officers and members of the Club. He was born in Baltimore June 3, 1800. He was the son of David Williamson, a well-known merchant of this city. At the age of 20 years he went into the auction business, on the corner of Baltimore and Charles streets, the present site of Canfield & Co's. store, the firm being Wilson, Williamson & Co. In September, 1831, he entered the National Union Bank of Maryland, remaining there several years, and going back into the auction business, the new firm being Williamson and Henry. He afterwards engaged in the dry goods trade, the title of the firm being Williamson, Sutton & Co. In December, 1852, he was reappointed to the Union Bank, where he remained until May 1, 1875, when he resigned in consequence of ill health, since which time he has been engaged in no active pursuits. For a number of years he was Italian consul at this port, but was obliged to give up the post. At the same time he resigned his office in the bank, and for the same reason. In religion Mr. Williamson was a Catholic, and served up to the date of his last serious illness as one of the trustees of the Cathedral, in which position he was the successor of his father. He was on terms of intimacy with the Archbishop of Baltimore, from the first Bishop to the present incumbent. His brother Adolphus was educated at Rome, and, becoming a priest, served as professor both at St. Mary's Seminary, Baltimore, and at Worcester, Mass. Gen. George W. Williamson, who died four or five years ago in New York, was also his brother. Mr. Williamson was liberal to the poor, and kindly and gentle in his disposition." Sun, Monday, 16 December 1878.

"The funeral of Mr. Charles A. Williamson took place yesterday morning from his late residence, No. 85 Franklin street. Rev. Wm. E. Starr read the prayers for the dead at the house. The remains were then borne to the Cathedral, the bell of which was tolled as the cortege approached and departed. Requiem mass was said by the clergymen of the Cathedral. Archbishop Gibbons gave the absolution. Rev. John Foley was present. The music was strictly Gregorian, under the leadership of Prof. Hurley. The pall-bearers were Thos. C. Jenkins, Charles Tiernan, Jr., Col. Wm. M. Boone, E. Austin Jenkins, Jr., James Hodges, Thomas C. Harris, L. M. Hopkins and Gilmor Meredith. Among the friends present were Otho Williams,





John B. Williams, Wm. Graham, Wm. Pennington, Henry Taylor, Jr., Hall Pleasants, Austin Jenkins, Sr., Washington Booth and Dr. W. Chew Van Bibber. The remains were conveyed to Bonnie Brae, where they were interred, Rev. Mr. Starr officiating at the grave." Sun, Tuesday, 17 December 1878.

h. Ann and Charles A. Williamson are buried in New Cathedral Cemetery (Bonnie Brae), North Half of Lot #62, Section "M". Their tombstones read :

48. Frank Jackson :

a. Christ Church Parish Register notes the burial of Frank Jackson, aged 1 year and 3 months





on 3 July 1851. He must therefore have been born in April 1850. He was 1 month old at the time of his enumeration in the United States Census of 1850 (see page 15, this MS.).

b. "DIED- On the 2d instant, Frank, aged 15 months, son of W. R. and the late Amelia Jackson." Sun, Friday, 4 July 1851. Buried in Greenmount Cemetery, Area "Q", Lot #46.

Issue of Captain John James Jackson and Eve Catherine Bier :

53. George Bier Jackson :

a. Christ Church Parish Register notes that George Bier Jackson, son of John James and Catherine E. Jackson was born 15 March 1850 and baptised 23 June 1850.

b. "GEORGE B. JACKSON- It was with much sorrow that the many friends of George B. Jackson learned of his sudden death in a distant land. He was a man of most genial and kindly nature, which attracted all who met him, and his sterling qualities of character commanded the respect as well as the lasting attachment of those who knew him well. His unswerving integrity was recognized by all those who encountered him in business transactions. He was a manly and honorable gentleman of the utmost loyalty of character, charitable in his judgement, forgiving in disposition, generous and as true a friend as one could find. Much attached to his native city, and to his family and friends here, he gave up his business in Baltimore two years ago to accept a responsible position in Brazil, expecting to return home in the course of another year. When the scourge of yellow-fever, from which he himself was to die- visited Santos more than a year ago, and carried off several of the little colony of those temporarily residing there, he stayed at his post, and at the risk of his life devoted himself to the care of his friends.

"George Jackson had a vein of quaint and pleasant humor which made him a charming companion. He was well read in the standard authors, and had an unusually retentive



memory, well-stored with good things in prose and verse from his favorite books, which he would quote with felicity. He did not care much for society in the generally accepted sense, nor at all for club life, but was fond of his home, of his books, and of the companionship of his friends. His good comradeship was apparent to all, and gained for him a wide popularity, and his true and kindly nature ensured for him the affectionate regard of his fellow men wherever his lot was cast." Sun, Tuesday, 14 March 1893.

c. The Tercentenary History of Maryland notes that the Edward A. Jacksons were childless, but adopted a small niece of Mrs. Jackson. The same source also notes that he was master of the hounds at the Elkridge Hunt Club.

d. "Funeral services for Edward A. Jackson, 67 years old, who died yesterday at the Union Memorial Hospital after an illness of several days, will be held at 4 P. M. today from the home, 501 Hawthorne Road, Roland Park. Burial will be in Greenmount Cemetery.

a. The elder daughter of Frances Elizabeth Jackson and John Tyler Seawell was born 23 October 1860 at the Shelter, the family plantation at Gloucester, Va., which had been a Revolutionary War Hospital.

"Mollie Elliott Seawell, one of the most widely read authors of books for boys and historical stories, died in her residence, 1767 P street northwest, at 5 o'clock yesterday afternoon, from a complication of diseases. Miss Seawell was fifty-six years old and had been a resident of Washington for thirty-five or forty years. Funeral services are to be held in St. Mathews Church at 10 o'clock tomorrow morning, with interment in Baltimore.

#### Active in Social Life

"She took an active part in social life. She was a hostess of note and entertained many brilliant and cultured men and women. She was an accomplished scholar and connoisseur of art. In late years, however, she had led a retired life, owing to the death of her mother and sister, and because of ill health.

Although she had begun writing sketches and stories in 1886, it was in 1890 that she



published her first novel, "Little Jervis". It took a prize of \$500 offered by the Youth's Companion for the best story for boys. Her "Sprightly Romance of Marsao", published in 1895, gave her first real fame. It captured the \$3000 prize offered by the New York Herald.

#### Author of Many Books

Three years later she captured another prize of \$1000 with her short story "John Mainwaring, Financier". Among her other books, in the order in which they were published, are "Midshipman Paulding", "Paul Jones", "Maid Marian", "Decateur and Somers, A Strange, Sad Comedy." "A Virginia Cavalier", "The Book of the Lion", "Twelve Naval Captains", "Gavin Hamilton", "The House of Endremont", "Papa Bouchard", "Franoezka", "The Secret of Toni", "Last Duchess of Belgrade", "The Marriage of Theodora", "The Ladies Battle", and "The Jugglers". Two of them, "Maid Marian" and "The Sprightly Romance of Marsac" have been dramatized.

Her "Twelve Naval Captains" has been adopted as a text book at the United States Naval Academy.

Miss Seawell was a strong advocate of free art and worked with a group of Americans, who fought for the removal of high duty on foreign pictures and other art treasures. She was a collector of note and at one time her home here was a mecca for lovers of art." The Evening Star, 16 November 1916.

"Miss Mollie Elliott Seawell, for many years one of the most popular women authors in the country, died today at her home 1767 P street, Washington, after a lingering illness. She will be buried Friday in Greenmount Cemetery, Baltimore, in the lot of the late William R. Jackson, to whose family she was related.

"Miss Seawell was the daughter of the late John Tyler Seawell and Frances Jackson Seawell, and was born in Gloucester county, Virginia. Her father was a nephew of President John Tyler. The only close relatives who survive her are four first cousins, Edward A. Jackson, 919 St. Paul st., Baltimore, and Mrs. Isaac Slingluff, Mrs. Emily Page Bryan, and Miss Mary G. Kemp of Virginia.

"In 1890 she won a prize of \$500 offered by a periodical for the best story for boys





called "Little Jervis"; in 1895 her "Sprightly Romance of Marsac", won a prize of \$3000 offered by the New York Herald; and in 1908 she won another prize from the Herald, \$1000 for "John Mainwaring, Financier". She published numerous other stories and a number of books and plays.

Miss Henrietta Seawell, sister of Miss Molly Eliot Seawell, the noted authoress of this city, died last night while en route from New York to this city. Accompanied by her sister and attended by Dr. Henry D. Fry of this city, Miss Seawell was placed on the midnight train at Jersey City. She became seriously ill on the steamer Zeeland, which arrived in New York yesterday.

"Miss Seawell was widely known in the social and literary circles of the city, and frequently assisted her sister in many brilliant social functions at her home, 1767 P





street.

"A dispatch from New York tells of the arrival of the Misses Seawell there and the summoning of Dr. Fry from this city by wireless telegraph. It says :

"As the Red Star liner Zeeland was covering the last few knots of her trip from Antwerp to New York yesterday, a special Pennsylvania railroad train was hastening hither Dr. Henry D. Fry of Washington whom wireless telegraph from the Zeeland had summoned to attend Miss Henrietta Seawell, sister of Miss Mollie Elliott Seawell, author, who was very ill aboard.

"Dr. J. W. Clarke, the ship's physician, at one time despaired of bringing his patient to port alive. Five months ago Miss Henrietta Seawell, suffering from heart trouble, went to Europe with her sister, stayed at Mannheim, and for a time was benefitted. In the last month she began to fail, and was determined to return to America.

"They boarded the Zeeland at Antwerp. Miss Seawell's condition improved, but yesterday morning she suddenly became very weak. It was suggested to Miss Molly Seawell that she get into communication as soon as possible with Dr. Frye, who had attended Miss Henrietta Seawell several times. The wireless apparatus was called into play, but the ship was too far at sea to reach Siasconsett. Finally communication was established at a distance of eighty-four miles, and an urgent message sent to the Washington physician.

"Miss Seawell was resting easily when the ship reached port, but it was said that her chances of recovery were slight.

"She was placed on the midnight train for the capital." The Evening Star, Tuesday, 4 October 1904. "DEATHS IN THE DISTRICT"- Henrietta Seawell, 35 years, 1767 P street, northwest, white. (Same, Thursday, 6 October 1904).

"Seawell- On October 4, 1904. Henrietta J. Seawell, daughter of the late John Tyler and Fannie E. Seawell of Gloucester county, Va.

"The funeral will take place from Union Station this Thursday, October 6, at 10 o'clock P. M. Interment private." Sun, Thursday, 6 October 1904.

c. She is buried in Greenmount Cemetery, Baltimore, Md. (see page 58 this MS).

60. James Biays Stump :

The wound which caused his death was a painful one, yet he bore it without a single murmur, and passed away without a struggle." American, Tuesday, 10 December 1839.

61. Pricilla Stump :

a. The second child of Sarah Biays and John Wilson Stump was born 14 October 1817 (Stump of Maryland).

b. She married John Leybold Griffith 26 June 1837, a son of Samuel Goldsmith Griffith and Mary Leybold. He was born 5 February 1810 (same). "THE HARFORD COUNTY MURDER- The examination of Mr. John Griffith, charged with being concerned in the murder of Henry Hammond, of Harford Co. on the 31st ult. which came off on Wednesday at Belair, resulted in the full discharge of the accused." - b. "Married Wednesday, by Rev. Lloyd Goldsborough, James Murray of Balto. Co. to Sarah Biays, 3rd daughter of John W. Stump, esq. of Oakington." (Dielman File from a newspaper dated Monday, 5 February 1838. They were married 31 January 1838. James Murray was born about 1812.
- c. "JAMES MURRAY- Mr. James Murray, whose death in London at the age of eighty-three years was mentioned in the Sun of yesterday, was a scientific and civil engineer, and was master-machinist of the Baltimore and Ohio Railroad fifty years ago and had his office at Mt. Clare. He formed a partnership with Mr. Henry R. Hazlehurst, of Ellicott City, in 1845, and established the Vulcan Iron Works and Machine Shop, at Hughes and William streets. After remaining in the firm ten years Mr. Murray became interested with the late Ross Winans in the building of the Winans Cigar Shop, and was sent to Europe by Mr. Winans. He was identified with all of Mr. Winans' work abroad. Mr. Murray had lived in London for twenty years. He had a son and three daughters. Two of his daughters married officers in the United States Army." Sun, Saturday, 30 March 1895.
- d. James Murray died 28 March 1895 in London, England.
- e. Sarah (Stump) Murray died in March, 1918 (Stump Genealogy).



- a. John Wilson Stump, Jr. (or II) was the sixth child of Sarah Biays and John Wilson Stump. He was born 15 October 1824 and named for his father.
- b. He was, according to the testimony of witnesses, to blame for the death of Henry Hammond, his uncle. See page #49ff, this MS and the Sun, Friday, 16 August 1850.
- c. He was employed in 1850 as an engineer at Harper's Ferry, Virginia; at the time of the murder, he had returned to Harford County briefly. He was never brought to trial for the deed, having fled immediately after its perpetration. The newspaper excerpts below were printed before all of the facts were obtained:

"ARREST UPON A CHARGE OF MURDER- A man named John Stump, it appears, has been arrested in Virginia, by the proper authorities, upon the charge of shooting Mr. Henry Hammond, who, it will be recollected, was killed a few days since, upon his farm near Perrymansville in consequence of being shot with a gun. It is further alleged that the accused was conveyed in a carriage to Hammond's farm by a Mr. Griffith, who has also been arrested. An examination of the matter will take place today at Belair." Sun, Wednesday, 14 August 1850. (See page #70, this MS).

"THE LATE MURDER IN HARFORD COUNTY- We have been informed that the murderer of the late Henry Hammond, of Harford County, is well known to the family of the deceased and the neighborhood generally, yet no efforts have been made to arrest him. But one cause has been assigned to the act- the perpetrator, a young man, smarting under the disgrace of a much beloved sister, and believing that the deceased was the author of his family's dishonor, vowed that he should not live, and fearfully has he kept his word. The young lady, it is said, is a niece of Mr. Hammond, and is rather weak in intellect. Argus." American, Tuesday, 6 August 1850.

- d. "MARRIED- At Harrisburg, Texas, on the 23d August, by Rev. J. J. Nicholson, John W. Stump, Jr., of Maryland, to Mary M., daughter of the late Maj. Birdsall, U. S. A. " Sun, Wednesday, 4 October 1854.

66. Mary Biays Stump (II) :

a. The seventh child of Sarah Biays and John Wilson Stump was the second to bear the name "Mary Biays Stump", her elder sister having died approximately two months before her birth, 14 November 1826.

b. She was an unfortunate child, afflicted by mental illness, described by some as feeble-mindedness, and others as periodic insanity (see her father's Will, page #37, this MS; also page #73, this MS). Her affliction was probably an indirect cause of the unfortunate death of her uncle, Henry Hammond.

c. She died, unmarried, 21 November 1881 (Stump Genealogy).

67. Margaret Ann Stump :

a. According to the Stump Genealogy, this child was born in May, 1828.

b. She died in infancy, 22 May 1828.

68. William Stump :

a. William Stump was the ninth child of Sarah Biays and John Wilson Stump. He was born in September, 1829 (same). In 1850 he was employed in Baltimore at Messrs. Samuel Harris & Sons.

b. According to testimony presented at the trial of his brother-in-law, John L. Griffith, William Stump accompanied John W. Stump, Jr. at the time of the fatal shooting of Henry Hammond, although the elder brother alone fired the shots.

c. William Stump married Mary Bartram North of Washington, D. C., 2 September 1857. She was a daughter of John Bartram North and Phoebe Harrison Rodgers of Washington. After the death of William Stump she married again.

d. "DIED- On Friday, 15th instant, at his residence Ellerslie, Harford county, Md., William Stump, son of John W. Stump, of that county, age 33 years." Sun, Tuesday, 19 August 1862.

e. He was a legatee of his father, John Wilson Stump, but died before him (see page #37, this MS).

f. "MARRIED- Leroy-Stump- On the 17th instant, at St. John's Church, Washington, by the Rev. W. F. Brand, Rear-Admiral Leroy, U. S. Navy, and Mrs. Mary B. Stump." Sun, Wednesday, 23 November 1881.

g. His full name was William Edgar Leroy (Stump Genealogy).

69. Thomas Bird Coleman Stump :

a. The tenth child of Sarah Biays and John Wilson Stump was born 7 September 1831. His middle name has also been spelled "Byrd".

b. He was questioned in regard to the fatal shooting of his uncle, Henry Hammond, and released (see page #51, this MS).

c. He was a legatee in the Will of his father, John Wilson Stump (see page #37, this MS).

d. He married Adeline Wray 11 October 1865. She was a daughter of James Wray and Eliza Findlay of Chambersburg, Pa. (Stump Genealogy).

e. "DIED- Stump- On Monday, April 15, 1912, Thomas B. Coleman Stump, in the 82d year of his age.

"Funeral on Wednesday April 17. Services at Emanuel P. E. Church, Belair, Md. at 2 o'clock. Interment in St. Mary's Cemetery, Emerson, Md." Sun, Tuesday, 16 April 1912.

70. Jane Stump :

a. The eleventh child of Sarah Biays and John Wilson Stump was born 10 September 1833. (Stump Genealogy)

b. She died in infancy, 9 August 1834. (same)



- a. The twelfth and youngest child of Sarah Biays and John Wilson Stump was born 8 August 1835.
- b. He was a legatee in his father's Will, and was designated to look after the interests of his sister, Mary Biays Stump, in the event of her incapability to do so (see page #37, this MS).
- c. Quite possibly Herman Stump became more famous than any other descendent of Abraham Jackson and Ann Alment mentioned in this paper. In later life he was known as Col. Herman Stump.
- d. He was engaged in politics for many years. In 1878 he was elected State Senator in the Maryland Legislature. He was president of the Democratic State Convention in 1879. The following year (1880) he became President of the State Senate. He emerged from state politics and entered national politics, being elected to serve in the United States House of Representatives in the 51st Congress. Two years later, he was re-elected to the 52nd Congress.
- e. Under President Grover Cleveland he became Commissioner General of Immigration. He was considered an authority on Italian immigration, and on two occasions went to Italy on a special mission.
- f. Herman Stump was a Mason- a member of Mt. Ararat Lodge, Belair, Md.
- g. Among his correspondents was his cousin, Henry Bowerman, whose descendents have preserved his letters.
- h. He was a man of many charitable enterprises. Among these was his service as President of the Rosewood Training School for Boys at Owings Mills, Maryland.
- i. While Immigration Commissioner he lived in New York. There he married another New Yorker, Mary Fernandez de Velasco, a descendent of Admiral de Velasco. They had no issue.
- j. Herman Stump died 9 January 1917.

k. Mary de Velasco Stump died 24 December 1944. A notice in the Sun gave her age as 91, which would place her year of birth as 1853.

72. Mary Jane Hoke :

a. Mary Jane Hoke, the oldest child of Anne Biays and Jacob Hoke, whose name has come to light is buried in Spesutia Cemetery, Perryman, Md. Her tombstone reads :

73. Kate Hoke :

a. Kate Hoke was born at Wilton Farm, Harford County, 15 September 1826. No record has been found to indicate that her name was ever spelled other than "Kate", but it would appear probable that she was named for her paternal grandmother, Catherine Hoke.

b. She married John Henry Greenway 21 April 1846.

c. Kate Hoke was well provided for by her father. A deed in trust, dated 27 April 1847, from Jacob Hoke and Ann B. Hoke of Wilton Farm to Edward M. Greenway, Jr.- in trust for Kate Hoke Greenway, her heirs, etc.- gave her possession of a farm near Havre-de-Grace which was purchased by Jacob Hoke 16 July 1832, containing 171 acres. Thirty additional acres of the original purchase were sold to Thomas C. Fletcher 31 October 1836. The deed





was witnessed by W. L. Nicoll and Geo. W. Hall (Harford County Land Records, Belair, Md., Liber HDG, folio #117. This farm was named "Hokeland", and became their eventual home, and birthplace of many of their descendants.

d. Kate Hoke was a legatee in the Wills of her mother and father, see pages #38 and #40, this MS.

e. "MRS KATE GREENWAY DEAD- Member of Prominent Family and Was Born in 1826- Mrs. Kate Greenway, member of a prominent Maryland family, died yesterday at her home, Hokeland Farm, two miles from Havre de Grace, on the Philadelphia turnpike.

"Born on the Wilton Farm, near Havre de Grace, September 15, 1826, Mrs. Greenway was the daughter of the late Jacob and Ann Biays Hoke. At her marriage to the late J. Henry Greenway, April 21, 1846, Mrs. Greenway was given the Hokeland Farm by her father.

"After the marriage, Mr. and Mrs. Greenway went to Europe, and upon their return lived in New York, where Mr. Greenway engaged in the grocery business until 1855. They returned to Baltimore, where Mr. Greenway continued the business, and later moved to Hokeland.

"Mrs. Greenway is survived by one daughter and two sons, Mrs. Virginia Greenway Albert, wife of Jacob Albert, of Govans; Eugene Greenway, of Baltimore, and Wilton Greenway, of Wiltondale Farm, Towson. She also leaves four grandchildren, Henry Greenway Albert, of Bistell, Ariz.; Miss Virginia Greenway Albert, of Baltimore; Miss Katherine Hilles Greenway and J. Henry Greenway, of Towson." (Date and source unknown).

f. Kate Greenway's Will is filed at the Court House, Belair, Md. It is dated 4 March 1904, and mentions her son, Eugene Greenway; and her grandchildren- Henry Greenway Albert and Virginia Greenway Albert, issue of her daughter, Virginia and her husband, Jacob Albert. It also mentions her grandchildren Katherine Hilles Greenway and John Henry Greenway, issue of her son, Wilton Greenway. Admission was granted 11 September 1913.

g. Kate Hoke Greenway is buried in Greenmount Cemetery, Baltimore. An elaborate marker adorns the family lot, while the names of the individuals buried there appear on flat slabs- as does hers. The inscription reads :

Died September 1, 1913

h. John Henry Greenway's Will is also on file at the Register of Wills Office, Belair, Md. He left his entire estate to his wife. The Will was admitted 1 May 1903.

i. John Henry Greenway is likewise buried in Greenmount Cemetery in the Greenway lot. His tombstone inscription reads :

74. Sarah Biays Hoke :

a. The second child of Anne Biays and Jacob Hoke to reach maturity was named for her maternal grandmother- and possibly her aunt, Mrs. John W. Stump. She was born- probably at Wilton Farm- 1 February 1829.

b. She was mentioned in the Wills of her mother and father- see pages #38 and #40, this MS.

c. "Married- At Wilton Farm, Harford County, Md., on the 17th instant, by Rev. Wm. H. Benade, of Philadelphia, Clarence E. Greenway to Sallie B. Hoke, daughter of Jacob Hoke." Sun, Thursday, 26 June 1856. A license was issued 13 June 1856 at the Court House in Belair.

d. Clarence Eugene Greenway died shortly after their marriage. Records of Greenmount Cemetery show that his body was removed from Harford County and reinterred in Greenmount 27 April 1858.

e. Sarah Biays Hoke married secondly, Joseph Henriques. A license was issued at the Court House in Belair, Md. 17 October 1863.





f. "DIED- On Saturday, April 7, 1900, at his late residence, "Wilton" near Havre de Grace, Md., Capt. Joseph Henriques, in the 75th year of his age.

"Funeral this (Tuesday) morning at 10 o'clock. Interment at Spesutia Church." Sun, Tuesday, 10 April 1900.

"JOSEPH HENRIQUES- Havre de Grace, Md., April 9-- Capt. Joseph Henriques died at his home near Havre de Grace Saturday morning, aged 75 years. He was a native of Jamaica. He served in the Mexican War and was a Captian in the Civil War." (samo).

g. Sarah Biays Hoke died 22 December 1910. Her Will was admitted at the Court House, Belair, Md., 4 January 1911. She died sine prole.

h. Both Sarah Biays Hoke and her second husband are buried in Spesutia Cemetery, Perryman, Md. Their tombstone inscription reads :

- c. She is buried in Spesutia Cemetery in the family lot. Her tombstone inscription reads :

77. Alexander Magruder Biays :

a. The eldest child of Philip Grable Biays and Jane Catherine Thomas Magruder was born 27 March 1826. He was baptised 2 May 1826 (St. Paul's Church Parish Register).

b. "Biays, A. Magruder, Mail Agent, Bds. 25 n. Calvert", Baltimore City Directory, 1858.

c. He is listed in an article about his sister's family and ancestry in Portrait and Biographical Record of the Sixth Congressional District.

d. His name appears on a deed, dated 1875, as one of the heirs of Philip G. Biays. Montgomery County Land Records, Rockville, Md.

e. "DIED- At Rio de Janeiro, of yellow fever on the 22d of January, A. Magruder Biays, formerly of this city, aged 32 years (Rockville papers please copy.)" Sun, Thursday, 14 April 1859.

78. John Hanson Thomas Biays :

a. The second child of Philip Grable Biays and Jane Catherine Thomas Magruder was also mentioned in the Land Records of Montgomery County, Md.

b. He died in "the Gold Fields of California" (Portrait and Biographical Record, etc.).

79. Sarah Stump Biays :

a. The third child of Philip Grable Biays and Jane Catherine Thomas Magruder died in infancy (Portrait, etc.).





a. The fourth child of Philip Grable Biays and Jane Catherine Thomas Magruder was born 26 April 1833. He is believed to have been a twin of his sister, Rebecca Thomas Biays.

b. He is listed as a merchant in T. H. S. Boyd's History of Montgomery County, 1879, page 140.

c. By deed, recorded 1 August 1870, James P. Biays and his wife, Rebecca, received from Benjamin F. Hodges and his wife Elizabeth W. Hodges part of Younger Brother for the sum of \$2400.00, Montgomery County Land Records, Liber EPB #7, folio #436.

The tract "Younger Brother lies west of Watt's Branch, and was surveyed for William Offutt, August 21st, 1719, containing six hundred acres, and comprises the farms of William Veirs and Joseph T. Bailey." Boyd's History of Montgomery County, page 34.

d. By deed in trust, recorded 30 November 1875 James P. Biays granted to William A. Veirs the farm "Springfield" for Rebecca Biays Veirs. Montgomery County Land Records, Liber EPB #14, folio #441.

e. Several other Montgomery County deeds include :

1. James P. Biays from W. Veirs Bouie, recorded 6 July 1878, Rel., Liber EPB #18, folio #261.

3. James P. Biays from Mortimer C. Griffith, bill of sale, recorded 24 September 1878. In this deed, James P. Biays received one mare and one crop of corn on a place known as "Coe" for a debt. (same, Liber EPB #18, folio #452).

4. James P. Biays received from Simeon Berry as mortgage for a debt, one bay horse and one carry-all and harness in a deed dated 18 April 1878 and recorded 5 April 1879 (same, Liber EPB #20, folio #122.)

f. He is listed among the heirs of Philip Grable Biays in 1875 (same).

g. There is also a deed from his brother-in-law, listed as "James P. Biays from Joseph H. Turner and Uxor, recorded 25 April 1879, (same, Liber EPB #19, folio #188).





h. He is mentioned in the article in Portrait and Biographical Record of the Sixth Congressional District, page 721ff.

i. "JAMES PHILIP BIAYS- Mr. James Philip Biays, who was for 12 years deputy clerk of the Court of Appeals, died yesterday, after an illness of a year, at his home, 212 East Twentieth street. Mr. Biays suffered a stroke of paralysis a year ago and the second about three weeks ago. He was born at Annapolis 70 years ago. He was a son of Philip G. Biays, one of the defenders of Baltimore in the War of 1812, a grandson of Col. James Biays, a member of the first City Council of Baltimore, and a great-grandson of John Hanson, whose statue will be placed with that of Charles Carroll of Carrollton in Statuary Hall at Washington. He was a lifelong Democrat and held his position at the Court of Appeals from 1879 to 1891. He was then a clerk in the State Treasury until 1895. Since that time he has resided in Baltimore. While holding his positions at Annapolis, he resided at Rockville and then at Upper Marlboro.

She, with two sons and a daughter, survive him. The sons are Messrs. James Philip Biays, Jr., and Benjamin H. Biays and the daughter is Mrs. R. H. Chappell." Sun, Tuesday, 5 March 1901.

j. James Philip Biays and his two wives are buried in Rockville Public Cemetery, Section "D", Lot #21. The tombstone inscriptions read :

a. Rebecca Thomas Biays was born in 1833 (a twin of James Philip Biays, most probably).

b. "May 3, 1853, Rebecca Thomas Biays was married in the Church of the Epiphany in Washington D. C., to William A. Veirs, of Maryland. On the same day they went south and took up their residence in Madison, middle Florida, where Mr. Veirs engaged in the mercantile business eight years. At the outbreak of the war they returned to Maryland and settled on their farm, Springfield, three miles west of Rockville. They had six children..... William Augustus Veirs was "the son of Samuel Clark Veirs and Juliana Diffenderfer, of Rockville. He was educated in the Rockville Academy." His mother was of the Baltimore Diffenderfer family (Portrait and Biographical Record of the Sixth Congressional District, page 721ff.

c. She is listed in the 1875 deed as one of the heirs of Philip Biays.

d. See 30 November 1875, Deed of Trust, James P. Biays to William A. Veirs, under James P. Biays, page 83, this MS.

e. She and William A. Veirs are buried in Rockville Public Cemetery, Lot #7. The tombstone reads :

c. The Portrait, etc. says that he died unmarried at Bay St. Louis, Louisiana. A glance at the map shows that this town is in Mississippi, not Louisiana.

83. Maria A. G. Biays :

a. She was 11 years old when the United States Census of 1850 was taken, must have been born, then, about 1839.

b. The Portrait, etc. says that she married Joseph H. Turner, a large slave and land owner of Prince George's County, and that they had six children.

c. See the deed listed under "James Philip Biays," page 83, this MS.

d. She was listed as one of the heirs of Philip Biays in 1875. She was then Mrs. Turner.

84. Henry Hammond Biays :

a. According to the Portrait, etc., Henry Hammond Biays died when very young.

85. William Jackson Biays :

a. He was 7 years old when the United States Census of 1850 was taken, must, then, have been born about 1843.

b. In 1875 he was listed as one of the heirs of Philip Biays.





c. He served with the Union Army during the Civil War.

"Lt. William J. Biays, Mar. 19, 1863- Dec. 29, 1863"

"William J. Biays 2nd Lieut. entered 19 March 1863, discharged 29 December 1863.

Entered the service as a private; promoted Second Lieutenant, March 20, 1863, 8th Regiment, Company I." History of Maryland Volunteers, Vol. I, page 325.

d. The Portrait and Biographical Record, etc., which was published in 1898, notes that he was then living in Sidney, Nebraska.

86. Francis Scott Biays :

a. He was listed as 5 years old in the 1850 United States Census, was born, then, about 1845.

b. He is listed in the 1875 deed as one of the heirs of Philip Biays.

c. He served with the Union Army during the Civil War, according to the History of Maryland Volunteers, Vol. I :

87. Fannie Hammond :

a. The eldest child of Fannie and Henry Hammond was born in Baltimore, 20 November 1828 and baptised 20 December 1828 (St. Paul's Parish Register). Spelled Fanny or Fannie.

b. A miniature, now in the possession of Mrs. Stonestreet Fowke of Baltimore, was painted by Rembrandt Peale; it shows Fannie, her mother and younger sister, Eliza.

c. "DIED- On Friday evening after an illness of three weeks, Fanny, eldest daughter of Henry and Fanny Hammond, aged nearly 5 years." Federal Gazette, Saturday, 3 August 1833.

d. She is buried in St. Paul's Cemetery, Baltimore, Md. Her tombstone reads :

Fanny Hammond

Eldest daughter of Henry and Fanny Hammond

died Aug. 2 1833

aged 5 years.

Henry Clay Hammond

died Apr. 28, 1837

e. St. Paul's Parish Register noted her burial, gave her age as "4 years".

88. Eliza Hammond :

a. The second child of Fannie and Henry Hammond was born in Baltimore, Md., 10 April 1830. A number of portraits of her exist, painted or photographed at various ages. All of them portray her bright red hair (see above- Fannie Hammond); Mrs. Richard O. Zerbo of Nitro, W. Va. has some later portraits.

b. After the death of her father in 1850, she appeared in court in connection with a suit styled "Allender vs. Hammond" which was designed to settle her father's estate. Final settlement was reached 7 April 1853. During the hearings she was asked her exact age by the court. (Chancery Papers, Liber #178, folio #1092, Hall of Records MS transferred to the Maryland State Office Building, Annapolis, Md.)





c. She was a legatee in the Will of her grandmother, Eliza Casey (nee Anderson). By its terms she was bequeathed "a mahogany bureau and work table, and one half of my Silver plate marked with the initials of my name." This will is dated 15 May 1847, and was granted admission 7 April 1849. In this instance she is called "Elizabeth Hammond"- the only instance which has come to light where her Christian name was other than "Eliza". Baltimore County Wills, Liber #23, folio #83. (All 8 surviving children were residual legatees)

d. In the United States Census of 1850 she was listed as 20 years of age.

e. "MARRIED- On the 3d instant, by the Rev. Dr. Wyatt, R. Neville Bowerman to Eliza, eldest daughter of the late Henry Hammond, Esq." Sun, Thursday, 5 January 1854. Richard Neville Bowerman and Eliza Hammond were first cousins, he being a son of Elizabeth Biays, sister of Fannie.

e. In 1870 Eliza Bowerman and her sister, Fanny B. Mahool, attended a ball at the Naval Academy in Annapolis with their husbands, the party from Baltimore taking a special steamer from Pier #7, Light Street. A description of the affair appeared in the newspaper- only an undated fragment of which was found. Another fragment, believed to be the same described the dress and floral hair arrangement of Mrs. General Bowerman.

f. "CELEBRATED GOLDEN WEDDING- General and Mrs. Richard Neville Bowerman celebrated the fiftieth anniversary of their marriage last evening at their home, Ross mansion, Gilmor lane, Waverly. The house was decorated with evergreens and holly, and a stringed orchestra, which furnished music, was concealed in a bower of palms. General and Mrs. Bowerman were assisted in receiving by their son, Mr. H. H. Bowerman, and their four daughters- Mrs. F. H. Potter, Mrs. William Richardson, and Misses Nanoy and Mildred Bowerman. About 200 guests were present, among whom were Captain and Mrs. J. S. Miller, Mrs. R. H. Atkinson, Miss Atkinson, Miss Courtney, of Washington; Miss Stewart and Miss Hayward, of Philadelphia, and Miss Weaver, of Dallas, Tex.

"General and Mrs. Bowerman were married at Old St. Paul's Protestant Episcopal Church on January 2, 1854, by the rector, Rev. Dr. Wyatt. Mrs. Bowerman was formerly Miss Hammond. The General is a member of the Grand Army Club." (unidentified newspaper article from the scrapbook of Anne Hammond Tubman.)





g. "Bowerman- On Thursday, September 1, 1910 at her residence No. 2313 North Charles Street, Eliza Hammond in her 81st year wife of Gen. Richard N. Bowerman and daughter of the late Henry and Fannie Biays Hammond.

"Relatives and friends are invited to attend the church service at St. John's P. E. Church, Waverly, this (Saturday) afternoon at 3 o'clock. Interment private." Sun, Saturday, 3 September 1910.

"Mrs Eliza Hammond Bowerman, 80 years old wife of Brig. Gen. Richard N. Bowerman, died at her home, 2313 North Charles Street, Thursday afternoon from heart failure, after an illness of three weeks.

"She was born in Baltimore on Hanover Street in 1830. She was the daughter of the late Henry and Fanny Biays Hammond. When 7 years old her family removed to Harford County and then returned to Baltimore where she resided on Calvert Street. It was from there that she was married to General Bowerman, the marriage taking place at Old St. Paul's Protestant Episcopal Church, January 3, 1854.

"When the General was mustered into the Union Army at the opening of the Civil War, on April 19, 1861, he and his wife had been living in New York for several years, and he was sworn in as a corporal in the Seventh Regiment, New York National Guard. He was mustered out June 10, 1865 as brigadier-general. During the time when he was in the army Mrs. Bowerman lived in New York and Baltimore, but was frequently with her husband in his camps.

"In January 1904, General and Mrs. Bowerman celebrated their golden wedding anniversary.

"Mrs. Bowerman was an aunt of Mayor Mahool.

"Besides her husband, she is survived by four daughters- Mrs. F. H. Potter, Mrs. William H. Richardson, Miss Mildred Bowerman, and Miss Nancy B. Bowerman. There are also seven grandchildren and one great-grandchild living.

"The funeral will take place at three o'clock this afternoon from St. John's Protestant Episcopal Church, Waverly. Services will be conducted by Rev. William Dallam Morgan, rector of the Church, assisted by Rev. D. P. Allison, assistant rector of St. Michael and All Angels Episcopal Church." (same).





h. She is buried in Greenmount Cemetery, Baltimore, Md., Area "Pine", Lot #11. The tombstone inscription reads :

Eliza Hammond Bowerman

April 10 1830- Sept. 1, 1910

"The Lord is my Shepherd"

89. Fannie Biays Hammond :

a. The third child of Frances Jackson Biays and Henry Hammond was born in Baltimore, Md., 27 May 1834 and baptised 19 April 1837. St. Paul's Parish Register, in which the baptism is listed, spells the name "Fanny Bias Hammond".

b. She was a residual legatee in the Will of her grandmother (see also section "g", page 48, this MS). The Will also states : "I give and bequeath to Fanny Hammond, daughter of said Henry Hammond a Mahogany Bureau and Work Box and the other half of my silver plate marked as aforesaid." (Will of Eliza Casey, Baltimore County Wills, Liber #23, folio #83).

c. A license was issued in Baltimore County 22 February 1856 for the marriage of Fanny B. Hammond and James Mahool, Jr. They were married 26 February 1856. He was born in Baltimore County 1 August 1828, and baptised James Franklin Mahool. His parents were James Mahool from Baltimore City and Sarah Cozine, born in New Jersey. Prior to the Civil War he assisted in the cotton factory in Franklinville, Md. of which his father was one of the controlling executives, and then was engaged in the fruit and candy business of Jordan, Crook & Co. at Pratt and Light Street. After the war he moved to Phoenix, Maryland and became a supervisor of cotton mills in several Maryland milling towns. He died at Guilford, Md., in Howard Co., their last place of residence together.

d. After the outbreak of the Civil War, James Mahool enlisted in the Confederate States Army, his enlistment dating 1 August 1863 at Atlanta. He became a Lieutenant in Old Co. "D", Second Battalion, Georgia Infantry (State Guards). A story without documentary proof states that on one occasion of a visit home- having slipped through the lines- his presence was discovered by his sister-in-law, Eliza Hammond Bowerman, whose Northern sympathies led





her to "turn him in" to the authorities.

e. After the War he became attached to the Maryland State Guard and was on Governor Bowie's staff. A commission dated 1868 shows that he attained the rank of Lieut.-Colonel. Various newspaper articles speak of him as "Colonel Mahool" and "Brigadier-General Mahool".

f. He became active in politics and was chairman of the Democratic Executive Committee of Baltimore County. One of his intimates was General James B. Gary, who became Postmaster-General of the United States.

g. Fannie and James Mahool attended the party at Annapolis in 1870 mentioned on page 89, section "E", this MS.

h. James Franklin Died in 1876. "DIED- Suddenly on the morning of December 20, 1876 at his late residence, Guilford, Howard Co., Md., James Mahool in the 49th year of his age. His friends will meet the body at Camden Street Depot on tomorrow (Saturday) morning at half-past ten o'clock where carriages will be in attendance to carry them to Greenmount Cemetery." Sun, Friday, 23 December 1876. He was buried in Greenmount Cemetery, Area "Pine", Lot #11. The grave is unmarked.

i. Fannie Hammond Mahool came to Baltimore with her family after her husband's death and took up residence on Gilmer St.

j. "DIED- On Wednesday evening, January 11, after a short illness, at the residence of her son, No. 113 West 23rd street, Fannie Hammond, widow of the late Col. James Mahool.

"Funeral from the above address this Friday, January 13, at 11 A. M. Interment private (omit flowers)." Sun, Friday, 13 January 1899.

"MRS. FANNIE H. MAHOOL- Mrs. Fannie H. Mahool, widow of Col. James Mahool, a well-known cotton duck manufacturer, died last evening at her home, 113 West Twenty-third street, after a short illness of pneumonia. Mrs. Mahool was sixty-five years of age, and was born in Harford county (sic). For the last twenty-two years she had been living in this city. Before that she resided in Guilford, Howard county, where her husband had a cotton duck mill. Col. Mahool died about twenty-two years ago, and was a member of the staff of Governor Bowie.





Mrs. Mahool was a member of the Maryland Avenue Presbyterian Church and is survived by four sons and three daughters." (Unidentified Newspaper Extract).

The "8500" after the name of James Mahool indicates the value of his real estate, and the "2000" the value of his personal estate. The "1" in the column after his place of birth shows that he was a male citizen over 21. (Same for Howell Lorman). The "1s" after the Mahool children's names show that they attended school within the past year. The "?" after the name of Mary McKew denotes a foreign place of birth of her father and mother. The final "1s" after her name and that of George Buckanan shows that they could neither read nor write. The census taker has confused the ages of "Fannie" and "Sallie" Mahool. The former was born in 1860, the latter in 1865.

1. Fannie Biays Hammond Mahool was buried in Greenmount Cemetery in Area "Pine", Lot, #11. Her grave is not marked.





90. Henry Clay Hammond :

94.

a. The fourth child of Frances Jackson Biays and Henry Hammond was born in Baltimore, Md. 16 February 1836 and baptised 19 April 1837 with his older sister, Fannie (St. Paul's Parish Register).

b. "Departed this life, on Friday, 28th April, Henry C. Hammond, son of Henry and Fanny Hammond of this city, aged 15 months." American, Wednesday, 3 May 1837. See page 88, this MS for his tombstone inscription in St. Paul's Cemetery, Baltimore, Md.

91. Henry Hammond :

a. The fifth child of Frances Jackson Biays and Henry Hammond was born 20 February 1838.

b. Testimony of John McGaw in the trial of John Leypold Griffith as an accomplice to the murder of Henry Hammond notes "about three thereafter he heard of the murder-- Master Henry Hammond, son of the deceased, coming in (his store) and stating that his father had shot himself-- at least he thought so. (It will readily be perceived that at first it was thought the deceased came to his death by his own hands) The young gentleman then, in reply to a question, told witness that his father was lying in the garden when he left and desired witness to go there." Dr. William H. Horton testified that Master Henry Hammond "called upon him for the purpose getting him to see his father, observing that he had shot himself."

c. His age is given as 12 years in the 1850 United States Census (see page #48, this MS).

d. "MARRIED- In New York, on the 12th instant, at the Church of the Incarnation, by the Rev. Dr. Montgomery, Harry Hammond, of Baltimore, to Adele C. Burke, daughter of William Moore, Esq. of the former city." Sun, Friday, 14 October 1859. (Another record- that of his granddaughter- says that she was Adele Cecilia Hopkins, daughter of Thomas Bradford Hopkins and Sarah Burke who were married in 1833.) Possibly she was a widow.

e. "Hammond- At New York, on April 2d, 1873, Adele C. Burke, wife of Henry Hammond, of Baltimore. (New Orleans papers please copy.)" Sun, Monday, 7 April 1873.

f. Henry Hammond died in New York City 29 March 1881. Both husband and wife are buried in New York.





g. Henry Hammond married secondly- Margaret Handy.

92. Anne Hoke Hammond :

a. The sixth child of Frances Jackson Biays and Henry Hammond was born in Harford County, Md., 6 June 1839, a date taken from a family record. She was known as "Nancy" and "Nanny" Hammond, and rarely used her given Christian name.

b. She was 11 at the time of the enumeration of the 1850 United States Census (see page #48), this MS. She was also a residual legatee of her grandmother's Will (see page 48, section "E", this MS).

c. "Married on 17 April 1866 by Father Coskery, Samuel A. Tubman of Cambridge to Nannie, 3rd daughter of Fanny and the late Henry Hammond." Sun, Saturday, 28 April 1866 (Dielman File). Samuel Alexander Tubman was born 17 October 1833, the son of Benjamin Gaither Keene Tubman and Margaret Jane Thompson from Frederick, Md.

d. Anne Hoke Hammond became a convert to the Catholic faith and raised her children in that church. She also kept a scrapbook of newspaper clippings of family interest.

e. "DEATH OF SAMUEL A. TUBMAN, SR. (Special dispatch to the Baltimore Sun) Westminster, Md., May 20- Mr. Samuel A. Tubman, Sr., died today at his home, near Westminster, Carroll county, aged sixty-four years. He had been ill for several weeks. He leaves a widow and two sons, Samuel A. Tubman, Jr. and Eugene Tubman, both of Baltimore. (undated clipping from Anne Hoke Hammond Tubman's scrapbook.) He died 20 May 1897 in Westminster, Md. and is buried in St. John's Church Cemetery in that city.

f. "MRS ANNE HAMMOND TUBMAN- Mrs. Anne Hammond Tubman, widow of the late Samuel Alexander Tubman, died last night at the home of her son, Samuel Alexander Tubman, Jr., 1641 North Calvert street. Mrs. Tubman was the daughter of the late Henry Hammond and Fannie Byas. She was born in Harford county and later moved to Carroll county. Mrs. Tubman was an aunt of ex-mayor J. Barry Mahool. She is survived by two sons, Samuel Alexander, Jr. and Eugene Tubman, of Westminster." Sun, Thursday morning, 24 February 1916.





92. Anne Hoke Hammond (continued) :

"Tubman- On February 23, 1916, at the residence of her son, No. 1641 North Calvert street, Anne Hammond Tubman, aged 76 years, wife of the late Samuel Alexander Tubman.

"Requiem Mass at St. John's Church, Westminster, Md., (Friday) morning at 10 o'clock."  
Sun, Friday, 25 February 1916.

93. John Barnet Hammond :

a. One of a set of twins, John Barnet Hammond was born in June 1840.

b. He died very young.

94. James Biays Hammond :

a. The twin brother of John Barnet Hammond (above), was likewise born in June, 1840.

b. He was a residual legatee of his grandmother's Will (see page 48, this MS).

c. In the United States Census of 1850, his age is given as 10 (see page #48, this MS).

d. He went to sea early in life. A letter from him to his mother on one of his voyages reads :

"Caleo December 11th 1855

Dear Mother

I have the opportunity of informing you that I am well and harty and have bin well the whole voyage we arived in port on the 2d after a passage of one hundred and Eighteen days from Baltimore we have had a very good time Except of the Horn where we lay two in a gale of wind for Six weeks blowing snowing and haleing all the time

I am very well Satisfide for our Ship is one of the first Class and our Capt and officers is very Kind and good natured as they can be

I never was treated so well on board of a Shipt be fore, and us boys gets along without any difficulty what Ever I am to tak my regular trick at the Wheel and perhaps I may be able to Ship for Ordermary Seaman the next voyage and Randy Benson he is getting along very well and



and is very handy on Board of the Ship I Expect we will lay hear about two months discharging Cargo and I will Endeavor to wright you again and let you Know where we will go to get a freight. I long to hear from you all at home but it is my last wishes and preys that you and all of my friends are well, give my bes respet to all my friends and tell Eliza to oiss little Fanny for me I wish you all a happy Christmaas. I Expect you would like to hear something about Caleo but I cant give you much description of the place now onley it is very hot and Sultry hear and it never reins this part of the world and of a night these falls a very heavy mist or dew but we arrived in a very good time for fruit but Every thing is very dear, but I will have to bring my letter to a close as it is near 2 O clock and it is our turn to hour

e. "Obituary- Lost at sea, on the night of Wednesday, November 26, from the ship John Clark, on the passage from Liverpool to Baltimore, when 100 miles outside Cape Henry, James Biays Hammond, in the 17th year of his age, second son of Fannie and the late Henry Hammond.

"Seldom does it become so mournful a duty as to record the death of one who now sleeps in a watery grave--- he who but a few short months since took his departure with prospects so glowing of a happy life and high distinction; but, alas, for worldly hopes, amidst bright visions of his happy home to which he was returning, his native shores almost in sight, the dread summons comes and a noble soul closes its earthly career. Yes, gone--- cut off in a moment whilst vieing with his shipmates alike for the post of danger and duty, amidst the roar of the heightened wind, the sea running mountains high, a black and dreary night, when, hark! amidst the crashing of spars and rending of canvas, one shriek is heard aloft, and the cold wave parts to receive our dear boy. Farewell, sweet Jimmy, you are





gone to meet your father in Heaven. Endowed with every virtue, the stamp of your noble nature on your clear manly brow, you endeared yourself to all by your kind and good qualities. But, alas, why should we dwell on such, for they belong now to Heaven. Death always chooses a shining mark, and has snatched from a fond mother her loving boy, just opening into manhood; and opened wounds that had ne'er been healed. Farewell--- whilst sleeping beneath the surging wave a widowed mother, fond brothers and sisters are weeping, playmates are mourning, and the young ones <sup>enquire</sup> anxiously after their Sailor Boy. Sleep on, dear boy." Sun, Monday, 8 December 1856.

f. Mrs. Katherine Mahool Fowke has an Episcopal Prayer Book which belonged to James Biays Hammond. Miss Mildred Bowerman related that the subject volunteered to go aloft to tend to the upper rigging during a storm, and was blown from his perch.

95. John Hammond :

a. The ninth child of Frances Jackson Biays and Henry Hammond was born in Harford County, Md., 21 May 1842. Also see page #43 this MS, sections "g" and "h".

b. "Hammond-Mullin- On November 8, at the parsonage of St. Pius Church, by Rev. Father Duggan, John Hammond and Mary E. Mullin, both of this city. (No cards.)" Sun, Monday, 12 November 1888. They had no issue. Her parents were John and Maria Mullen.

c. "JOHN HAMMOND- Mr. John Hammond died yesterday morning of heart disease at his home, 1105 West Lanvale street. Mr. Hammond had been sick about six months. He was 58 years old and was a son of the late Henry Hammond. He was a member of the Order of Heptasophs. A widow, who was Miss Mary Mullen, survives." Sun, Wednesday, 27 March 1901.

"DIED- On March 26, 1901, John, in his 59th year, beloved husband of Mary E. Hammond, and son of the late Henry and Fanny J. Hammond.

"Funeral from his late residence, No. 1105 West Lanvale street, on Thursday morning, at 9 o'clock. Requiem Mass at St. Pius' church at 9:30 o'clock. Interment private." (same)





d. "JOHN HAMMOND- The funeral of Mr. John Hammond, who died Tuesday, took place yesterday morning from St. Pius' Catholic Church, Edmonson Avenue and Schroeder street, where a low mass of requiem was celebrated at 9 o'clock by Rev. C. P. Elbert. The pallbearers were Messrs H. Hammond, George S. Bowerman, James and J. Barry Mahool, Samuel A. and C. E. Tubman, Charles H. Rea and P. W. Keech, all nephews of the deceased. The interment was in Bonnie Brae Cemetery." Sun, Friday, 29 March 1901.

e. "HAMMOND- On March 15, 1923, Mary E., beloved wife of the late John Hammond.

"Funeral from the residence of her niece Mrs. P. Wall Keech, 1300 North Calvert street on Monday at 8:45 A. M.; thence to St. Ignatius Church, where Requiem Mass will be offered at 9:15 A. M. Interment in New Cathedral Cemetery." Sun, Saturday, 17 March 1923.

f. The office at New Cathedral or Bonnie Brae Cemetery notes that Mary E. Mullen Hammond was seventy years old at the time of her death; she was, therefore, born about 1853.

g. There are three tombstones standing in the Hammond Lot- (Section I, Lot #22), which read :

a. Sally Hammond was born in Harford about 1843. She was recorded at Spesutia Church, St. George's Parish, Harford Co., Md. 2 October 1846 when "about 3 years old". (St. George's Parish Register).

b. The recording mentioned above noted her death on that date.



- a. The eleventh child of Frances Biays and Henry Hammond was born 7 July 1845 in Harford County according to a family record. St. George's Parish Register (Harford Co.) notes her baptism 27 December 1846 "aged about three years".
- b. She was a residual legatee in her grandmother's Will, and was listed as "5" in the 1850 United States Census (see pages #48 and #49, this MS).
- c. She was taken into the home of her aunt, Hannah Jane (Biays) Allender when young and raised there. A portrait of her in a riding habit once hung at Mt. Ararat, which she inherited when her aunt and uncle died.
- d. "BOWERMAN-HAMMOND- On the 7th instant, by the Rev, Dr. Mahan of St. Paul's Church, James Biays Bowerman to Miss H. Jane A. Hammond, fourth daughter of Fannie and the late Henry Hammond, all of this city." Sun, Thursday, 15 August 1867. James Biays Bowerman was her first cousin, a son of Elizabeth Biays and Henry Neville Bowerman.
- e. "Bowerman- On January 3, 1920 at 9:40 A. M. in Jacksonville, Fla., Hannah Jane Hammond, widow of James Bowerman.  
"Funeral from the residence of her son, 407 East Twentieth street, on Wednesday morning at 8:30 o'clock, thence to St. Ann's Catholic Church where Requiem High Mass will be said for the repose of her soul at 9 o'clock. Interment in St. Stephen's Cemetery, Bradshaw, Baltimore county." Sun, Wednesday, 7 January 1920.
- f. Her grave in St. Stephen's Cemetery is unmarked.
- g. "On April 24 at his late residence, Loreley, Baltimore county, Md., James Brays (sic) Bowerman, beloved husband of Jane A. Bowerman.  
"Interment at St. Stephen's, Bradshaw, on this Monday, at ten o'clock A. M. Relatives and friends are invited." Sun, Monday, 27 April 1896.
- g. James Biays Bowerman's grave id also unmarked.





a. The twelfth and youngest child of Frances Jackson Biays and Henry Hammond was born in Harford County, Md., 5 March 1849 and baptised 2 April 1849 (St. George's Parish Register).

b. She was listed in the United States Census of 1850 as "1" year of age (see page #49).

c. Record from the Marriage License Bureau, Court House, Baltimore, Md. :

Von Stamp, Hendrie, Balto., Age-54, white, widower and Hammond, Mildred, Balto., age-34, white, single; Issued 10 June 1892; married 12 June 1892; filed 2 September 1892; Minister- A. F. Sterger; Remarks- BK #4, 1892 J. T. G., folio #155.

d. Colonel Von Stamp's full name was Hendrie Maurice Frederick Wilhelm von Stamp. He was twice married, vizt. : "STAMP-CHAPMAN- On the 8th instant, by the Rev. John N. McJilton, D. D., at the residence of the bride's father, Hendrick M. F. W. Stamp, of the Royal Danish Army, and the late Chief Engineer First Army Corps of Major General W. S. Hancock's Staff and Aid-de-camp to Major General S. S. Carroll, U. S. A., to Elizabeth, eldest daughter of Hon. John Lee Chapman." Sun, Monday, 10 December 1866.

"STAMP- On the 26th of June 1869, Elizabeth, wife of H. M. F. V. Stamp and eldest daughter of John Lee Chapman.

"The relatives and friends of the family are invited to attend her funeral from her parents residence on tomorrow (Tuesday) morning at ten o'clock." Sun, Monday, 28 June 1869.

e. Besides the talents mentioned in the various extracts in this text, Col. von Stamp was an amateur artist of considerable skill. Numerous examples of his work exist, including a picture of the Bowerman home, "Mt. Ararat".

f. "WEDDED IN A GRAVEYARD

A MOST UNUSUAL CEREMONY IN GREENMOUNT CEMETERY

Mildred Hammond Made the Wife of Hendrie von Stamp While She  
Stands Upon Her Mother's Grave, and He Upon That of Her Father-  
Bricklayers Back Up the Carpenters.

"Six carriages drove into Greenment (sic) Cemetery yesterday morning at ten o'clock.





"It was not a funeral party, as one would be privileged to judge, but a glance at the occupants with their happy faces and merry faces, betokened something entirely different.

"Strange as it may seem, it was nothing better nor worse than a bridal party. Two hearts were going there to be made one, and hear and receive the blessing of the minister on the graves of the parents of one of those who were plighting their troth.

"The choice of a graveyard for the performance of a marriage ceremony was due to the sentiment of the happy bride and her devotion to the memory of her parents, who for two decades have lain buried in Greenmount.

"The groom was Col. Hendric von Stamp, of Washington, D. C., and the bride Miss Mildred Hammand, daughter of the late Gen. Howard Hammond (sic).

"The party proceeded to the Hammond burial lot, near the spring in the cemetery, and there, the bride standing upon the grave of her mother, and the groom standing upon the grave of the bride's father, with hands clasped, Rev. A. F. Sterger, pastor of German Trinity Church, Trinity street near High, pronounced them man and wife. The lot was handsomely decorated with flowers.

"The witnesses to the marriage certificate were Major Morris Jackson and his wife Matilda Jackson, and Harold Jackson, consul of Denmark in Baltimore, and Mr. Julius Jackson.

"The bride is of one of Maryland's oldest families, being a remote descendent of President George Washington.

"The groom had the honor of introducing Prof. Haerik some time ago, of the Peabody, to the King of Denmark, the introduction resulting in the decoration of the professor.

"The party immediately after the marriage ceremony proceeded to the Hotel Rennert, where a reception was held and dinner was served. At 2 P. M. the happy couple went to Washington, from which place they will go on a two months' cruise in the groom's yacht, the Mildred, the yacht being named after the bride.

"The groom is forty-four years of age, and the bride about forty. The bride has lived for years on Charles street extended. The affair was conducted with such secrecy that even the witnesses, nor any of the bridal party, except the bride, the groom and Rev. Dr. Sterger, knew where the ceremony was to be performed until after the carriages had passed





through the portals of Greenmount, and were standing beside the Hammond lot. The uniqueness of the whole situation was too much for those employed in the cemetery, and they were all attracted to the spot, and gazed upon the strange spectacle with wondering eyes.

"Rev. Dr. Sterger was first apprised that his services would be required on Saturday last (unidentified newspaper clipping from the scrapbook of Anne Hammond Tubman).

g. "CAREER OF COL. VON STAMP

Death of a Remarkable Man Who Will Be Missed on Staten Island -----

"The death of Colonel Hendric M. F. von Stamp, C. E., which occurred Friday morning, January 5, deprives Staten Island of an honored citizen. Though born on the other side of the Atlantic, he was, in spirit, so thoroughly an American that he may well serve as an example of patriotism to the younger generation.

"The date of his birth was August 4, 1837. He entered the Danish army and fought against Austria and Prussia.

"Coming to this country, he offered his sword to our government, and fought through the Civil War in Company G, 2nd U. S. Volunteers, as first lieutenant and later as captain. He was a staff-mate of Major, then Captain, William McKinley, and the friendship begun at that time lasted up to the day of President McKinley's tragic death.

"Colonel von Stamp took out his final naturalization papers in 1869. In June, 1892, he was married to Miss Mildred Hammond, of Baltimore. Both parties being averse to elaborate weddings, they decided upon a unique plan. They were married in the cemetery where the bride's parents were buried, the bride standing upon the grave of her mother, and the bridegroom upon that of her father. It is said that this is an old Danish custom. The wedding journey was made on the yacht "Mildred", owned by Colonel von Stamp and named in honor of his bride.

"He was engaged upon many important engineering feats, one being the building of the Western Maryland Railroad through the Blue Ridge Mountains. The plan that he, in company with another engineer, devised for the water supply for the city of Baltimore was so elastic





that it is now being extended, but not materially altered, to meet the need of the growing city. His plan was made nearly fifty years ago.

"He held various positions under the government, much of the last twenty-five years being spent in the Immigration Department, from which he was retired in August, 1920.

"It was a source of deep regret to him that when his adopted country entered the World War he was too far advanced in years to take an active part, but he was in some measure consoled by the knowledge that, in going on with his work in the Immigration Department at an age when most men consider their life-work finished, he was thereby releasing some younger man for active service.

"He was a man of wide and varied knowledge, speaking ten languages, being an artist of no mean skill, a civil engineer of note, and a soldier of distinction.

"A gallant officer and a kindly gentleman has left us, after a long life of usefulness to the land of his adoption.

"The funeral was held from his late residence on Sunday afternoon, the service being read by Rev. Dr. Foster of Christ Church. Two solos were sung by Mr. Gutekunst of the Christ Church choir." (Unidentified newspaper clipping from the file of Mrs. Katherine Mahool Fowke).

Mary Grace Bowerman was a first cousin of William Henry Bowerman. Their fathers were Richard P. Bowerman and Henry Neville Bowerman, respectively (see page 51, this MS). Richard P. Bowerman married Margaret H. Gillis, daughter of Z. Gillis of Somerset County, Md., 13 September 1838. The Dielman File, Maryland Historical Society, notes that "d.- 31 May 1845- Richard Bowerman, native Limerick Ireland, last 20 years respected citizen, in his forty-second year, leaving wife and four children." In the 1842 City Directory, he was listed as a tobacco inspector, Barre Street, west of Charles.

After his death, Margaret (Gillis) Bowerman operated a confectionary store, listed in the 1867/68 City Directory at 416 West Fayette Street. She is remembered as a nice little lady who walked with a limp. The same issue notes that her daughters, Emma and Grace, lived with her. (Emma is probably a misprint for Emily).

Among their children were :

1. Emily Jane Bowerman, born 29 August 1840, baptised 2 June 1847 (St. Paul's Parish Register).

2. Richard Bowerman, born 11 September 1842, baptised same day, as above.
